PROBABLE CAUSE

On the above date time, I was responding to a traffic stop as a backup officer for Tpr. Z. Todd (1729). When I arrived on scene, Tpr. Z. Todd advised me that he was responding to a call in reference to a pedestrian running into ongoing traffic on State Road 9 (I-95), near the area of Congress Ave. Tpr. Z. Todd advised when he arrived on scene, that he observed a white male, was running on the right paved shoulder on I-95, to a tan colored SUV parked on the right paved shoulder. Tpr. Z. Todd further advised that he observed the white male pedestrian get into the SUV in the driver seat, and began to drive northbound on I-95. Tpr. Z. Todd then activated his emergency lights and sirens to initiate a traffic stop on the tan SUV. Shortly after the SUV came to a controlled stop on the right paved shoulder on I-95. Tpr. Todd removed the driver, who was later identified by his Florida Driver's License number R525433893240 as Joshua Rongione. Tpr. Z. Todd advised me while speaking with Mr. Rongione, he observed Mr. Rongione to have an odor of an unknown alcoholic beverage coming from his mouth and breath area. I then became the primary Trooper on scene to conduct a Driving Under the Influence (DUI) investigation. I approached Mr. Rongione and asked him why he was running on a limited access facility (I-95). Mr. Rongione advised me that he was in an argument with his girlfriend. When Mr. Rongione advised his girlfriend to pull the SUV over so Mr. Rongione could exit the vehicle. Mr. Rongione advised that his girlfriend did so. Mr. Rongione advised that he exited the SUV and began to run northbound on the right paved shoulder and the outside travel lane. Mr. Rongione advised me that his girlfriend exited the SUV and began to run behind him. Mr. Rongione advised that once his girlfriend caught up to Mr. Rongione, that she threw the key to the SUV at his feet and advised him to leave. Mr. Rongione advised me that he then took possession of the keys and ran to the SUV, getting in the driver seat and driving off. Mr. Rongione advised me then shortly after that he was pulled over by a Trooper (Tpr. Z. Todd). While speaking to Mr. Rongione, I observed him to have an odor of an unknown alcoholic beverage coming from his mouth and breath area. I asked Mr. Rongione did he consume and alcoholic beverages prior to driving. Mr. Rongione advised yes, that he had four (4) beers and one (1) shot of alcohol earlier in the night.

When asked, Mr. Rongione agreed to submit to a series of field sobriety exercise.

Horizontal Gaze Nystagmus exercise

Prior to beginning the exercise it was determined Mr. Rongione was not wearing contacts. Mr. Rongione's eyes were checked and his eyes displayed equal tracking and his pupils were equal sizes. Mr. Rongione was instructed to following the stimulus with his eyes only, keeping his head still. After stating he understood the instructions Mr. Rongione attempted this exercise.

The results of this exercise displayed 6 of the 6 possible clues.

- A lack of Smooth Pursuit in his left eye.
- A lack of Smooth Pursuit in his right eye.
- A distinct and sustained nystagmus in the left eye at maximum deviation.
- A distinct and sustained nystagmus in the right eye at maximum deviation.
- An onset of nystagmus in the left eye prior to 45 degrees.
- An onset of nystagmus in the right eye prior to 45 degrees.

While performing the Horizontal Gaze Nystagmus exercise, it was observed that Mr. Rongione:

- Moved his head from side to side during the exercise.
- Swayed while standing.

Walk and Turn exercise

Prior to attempting this exercise, Mr. Rongione indicated he did not have any medical problems that would have prevented him from performing the exercise. Mr. Rongione was instructed to put his left foot on the line and his right foot in front of it with his right heel touching the toe of his left foot. He was instructed to stand in this manner with his hands to his sides until the exercise instructions were completed and the exercise demonstrated. Mr. Rongione was instructed not to begin the exercise until told to start. He was instructed to take nine steps along the line in a heel-to-toe manner. After the ninth step he was to stop and turn around keeping his lead foot on the ground, taking several small steps with the other foot to turn around. After turning around he was to take nine steps in a heel-to-toe manner back along the line, in the direction he had come from. Mr. Rongione was further instructed to watch his feet at all times while walking, keep his arms down to his side, and to count his steps out loud. After the exercise was demonstrated Mr. Rongione stated he understood the instructions and was instructed to begin the exercise.

- After attempting the Walk and Turn exercise Mr. Rongione displayed 3 of 8 possible clues.

Walk and Turn exercise observations:

- On the first set of steps Mr. Rongione failed to walk in a heel-to-toe manner on 3 steps, failing to walk heel-to-toe on steps 3, 5, and 6. Mr. Rongione then stepped off the line on 1 step, stepping off the line on step 7.

- On the second set of steps Mr. Rongione failed to walk in a heel-to-toe manner on 3 steps, failing to walk heel-to-toe on steps 2, 3, and 6. Mr. Rongione then stepped off the line on 1 step, stepping off the line on step 5.
- Was unable to stand in a heel-to-toe manner while the instructions to the exercise were given.

One Leg Stand exercise

Prior to attempting this exercise, Mr. Rongione indicated he did not have any medical problems that would have prevented him from performing the exercise. Mr. Rongione was instructed to stand with his heels together and hands down to his sides while the instructions were given and during the exercise. Mr. Rongione was instructed not to begin the exercise until he was instructed to start, and after the exercise had been demonstrated. When instructed to start, he was to raise the foot of his choice off the ground approximately 6 inches. While his leg was raised he was to keep his leg straight, watch his raised foot, and to count out loud by thousands (one thousand one, one thousand two, one thousand three...) and to continue the exercise until told to stop (30 seconds). After this exercise was demonstrated and indicating he understood the instructions Mr. Rongione attempted this exercise.
When Mr. Rongione attempted this exercise he raised his left foot.
The result of this exercise displayed 4 of the 4 possible clues.
During this exercise Mr. Rongione:
- Swayed during the exercise.
- Used arms for balance.
- Hopped during the exercise
- Put his foot down (2 time(s) during the exercise).

After I completed the Standardize Field Sobriety Exercise observations on Mr. Rongione, I then placed Mr. Rongione under arrest for suspected driving under the influence (DUI) of alcohol. I then placed Mr. Rongione in the rear of my patrol vehicle, and secured him in. Shortly after, I departed the scene enroute to the Palm Beach County Jail. Upon arrival at the jail, I escorted Mr. Rongione to the BAT center. There, I conducted a 20 minute observation period of Mr. Rongione. Once the 20 minutes were up, I escorted Mr. Rongione into the BAT room. Once there, I requested Mr. Rongione to submit to a lawful test of his breath for the purpose of determining its alcohol content. Mr. Rongione agreed to submit at 4:39AM. Mr. Rongione provided an adequate breath sample of .096 at 4:44AM and another breath sample of .096 at 4:46AM. I then concluded my DUI investigation and transported Mr. Rongione to booking into the Palm Beach County Jail. Shortly after, Mr. Rongione was booked into the Palm Beach County jail on 316.193.1 Florida Statue Misdemeanor DUI. All events occurred in Palm Beach


