On October 26, 2017, the crime of Sexual Battery occurred at 550 S. Rosemary Ave., West Palm Beach, Palm Beach County, Florida 33401 (Copper Blues Restaurant).


During a sworn statement, the 27-year-old female victim disclosed the following: On October 25, 2017, she went to Copper Blues with a friend. She had one alcoholic drink at the bar and used the restroom. She then left to a friend's residence nearby and had a second alcoholic drink. She then returned to Copper Blues with her friend. The next thing she remembered was police surrounding her and telling her "something" happened. She did not recall anything between arriving back at Copper Blues and the police speaking with her.

According to cooperating witnesses, the suspect Joshua Thomas Sullins, sexually assaulted the victim while she was unconscious inside Copper Blues. During the victim's interview she was shown a photograph of Sullins and she denied knowing him and said she would not have consented to having sexual intercourse or sexual contact of any kind with Sullins.

During sworn statements, three cooperating witnesses witnessed Sullins sexually assault the incoherent victim on the restroom floor of Copper Blues.

Sullins fled the scene but was apprehended by police soon after. During a post Miranda interview, Sullins denied having sexual intercourse with the victim but said he possibly touched the top of the victim's vagina with his hand after she kissed him.

Based on the above mentioned facts, your Affiant finds probable cause exists to arrest Joshua Thomas Sullins and charge him in violation of F.S.S. 794.011(4) Sexual Battery on a Victim over 12yoa Special Conditions.

On 10/26/17 at approximately 0120 hours I was dispatched via WPBPD radio to a sexual battery that just occurred at 550 S Rosemary Ave (Copper Blues).

While enroute dispatch advised that the suspect (white male wearing black shirt, and camouflage pants) was running from the scene with a Copper Blues employee (B/M Jalon White) following him.

I was headed south on S Rosemary Ave approaching Gardenia St when I observed/heard Jalon White flag me down, and pointing in the 500 block of Gardenia St (east of S Rosemary Ave) toward the garbage/compactor bay area on the south side of Gardenia St.

I exited my marked wpb patrol vehicle (x-2002) heading toward the garbage/compactor bay area on foot where I observed the subject who matched the description of the suspect given over main air behind dumpsters/compactors who observed me in full police uniform (EDU uniform). Witness, Jalon White also advised that the subject I observed was the suspect he had followed from Copper Blues. The suspect then took flight. It should be noted that there was no other person in the bay area where the suspect was located.

I gave loud verbal commands "police stop" to the suspect who was attempting to evade capture which he refused and continued to take flight eastbound into a hallway from the garbage/compactor bay. I observed the suspect at the end of the hallway right in front of the double doors where he turned himself around, now facing me, making eye contact while taking an aggressive stance. I closed the gap quickly with a forward push to the upper torso which propelled the suspect into the closed double doors (now open) behind him where he landed on his back on top of carpet. The suspect still moving in attempt to get up onto his feet was flipped over onto his stomach where I could maintain pressure on top of the suspect to keep him from getting to his feet. The suspect was still attempting to move his body and hands as officers were facilitating handcuffing. The
