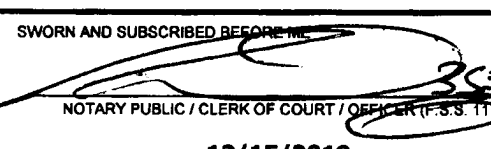

PROBABLE CAUSE STATEMENT	On 12/15/19 at 12:52 a.m. I, FTO Melinda Hanton, responded to 4134 Holly Drive in the City of Palm Beach Gardens, Palm Beach County, Florida; in reference to a domestic battery. Upon arrival I activated my department issued body camera and met with the homeowner, Elving L. Torres and Casey L. Vincent. Officer Barker separated the female, Vincent, and I spoke with Torres. I swore Torres in on body camera and asked him what happened. Torres stated that his friend, Vincent, recently broke up with her boyfriend, Juan Llenza Aponte, and that he showed up at his house. Torres stated that Llenza Aponte entered his back yard and then the patio area and saw Vincent wearing a robe and "freaked out". Torres stated that Llenza Aponte started yelling and ripped open the robe, grabbed Vincent by the neck and threw her up against the screen and then the wall. Torres stated he grabbed his cell phone to call 911 and told Llenza Aponte that he was calling the police. Llenza Aponte then threw the cell phone to the ground and back handed Torres to the left side of his face and pushed him into the wall. Torres advised that when he told Llenza Aponte that the police was coming, Llenza Aponte then entered the house, and ran out of the front door to get away. I asked Torres if he wanted to press charges against Llenza Aponte and he said yes.								
	Officer Barker swore in Vincent and she stated the following: after an earlier confrontation with Llenza Aponte, he showed up at the house. Llenza Aponte then pushed Vincent in the chest, below her neck, and then shoved her forehead and pushed her against the wall. Vincent had a red mark on her chest area below her neck. Vincent advised that she was in a romantic relationship with Llenza Aponte for approximately 9 months.								
	Llenza Aponte left the residence and went to the Pirates Well. Officers went to the Pirates Well and made contact with Llenza Aponte and read him his Miranda rights. Llenza Aponte advised he went to the residence, knocked on the front door and no one answered. Llenza Aponte stated he went around to the back, entered the back yard and

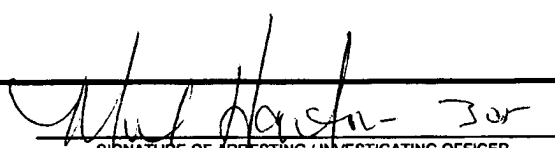
saw Vincent naked, and entered the patio to confront Vincent and Torres. After confronting both Vincent and Torres, Llenza Aponte stated he exited the patio and left the residence. Llenza Aponte stated that he and Vincent were in a relationship for 8 months.

While at the residence with Vincent and Torres, Llenza Aponte was texting and calling both Torres and Vincent. The texts from Llenza Aponte to Torres were threatening to sink his boat, and putting the altercation on social media. Llenza Aponte was using profanity and when Sgt. Beath answered the phone when Llenza Aponte was calling, Llenza Aponte answered the phone making threatening comments. The text messages from Llenza Aponte to Vincent were also using profanity and calling her names.

Vincent and Torres were both provided victim's right packets and Vincent was issued a Domestic Violence packet.

Per my investigation I find Llenza Aponte did intentionally touch and strike Vincent, who he was in a dating relationship with, in violation of Florida State Statute 784.03(1)(a)(1).

Llenza Aponte did also intentionally touch and strike Torres in violation of Florida State Statute 784.03(1)(a)(1), and entered Torres's residence with the intention to commit a battery, in violation of Florida State Statute 810.02(2)(a).
