It was apparent that Fino Molina did not speak very good English, therefore, I radioed for a Spanish speaking Deputy.

Deputy A. Raja showed on scene and asked Fino Molina if he had any alcoholic beverages tonight. Fino Molina responded yes.

At this time, I radioed for a DUI unit (Deputy K. White) to assist with conducting roadside Sobriety field test on Fino Molina. Deputy White appeared on scene and assessed Fino Molina's current state. Deputy K. White was able to determine that Fino Molina was under the influence of alcohol and unsuitable to operate his motor vehicle.

Fino Molina was arrested and transported to the County Jail for D.U.I.

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On Friday, December 30, 2016 at approximately 0230 hours, I was dispatched to Forest Hill Boulevard, West of South Military Trail, West Palm Beach (Palm Beach County) Florida to assist Deputy LaShawna Edwards with a traffic stop that involved a possible drunk driver. Upon my arrival I noticed a black BMW stopped on the north curbs shoulder of the westbound lane roadway facing east. It was partially resting in an exit lane of Stanton Optical. I also saw black tire yaw marks in the roadway that signified the vehicle spun to its final resting place on the curb. I spoke with D/S Edwards who wrote a sworn witness statement on a probable cause affidavit which entailed the following: On December 30, 2016 at 02:17hrs, while patrolling the area of Forest Hill Blvd and Military Trail, West Palm Beach FL, 33405, I observed a black BMW (Tag: Y03NRB) approaching this intersection. The BMW was heading south on Military Trail and made its way to the turning lane to head westbound on Forest Hill Blvd.

I was stopped at a red right facing eastbound on Forest Hill Blvd. in attempts to go northbound on Military Trail. This is when I heard the black BMW spin its tires at a high rate of speed. I turned my head towards the direction of the noise and observed the black BMW spinning uncontrollably. The vehicle came to its final rest onto the curbside. The vehicle was now facing eastbound on Forest Hill Blvd. in the westbound lanes.

I notified dispatch of this occurrence and made a u-turn towards the vehicle. I then made contact with the driver later identified as Juan Camilo Fino Molina. Molina was asked to present me with his Florida driver's license, registration and proof of insurance. Molina was able to do so. Let it be known that Molina's eyes were glossy, reddened and his breathe smelled of alcohol. I asked Molina in Spanish if he had any alcohol tonight and he stated no.

It was apparent that Molina did not speak very good English, therefore, I radioed for a Spanish speaking Deputy. Deputy A. Raja showed on scene and asked Molina if he had any alcoholic beverages tonight. Molina responded yes.

At this time, I radioed for a DUI unit (Deputy K. White) to assist with conducting roadside Sobriety field test on Molina. Deputy White appeared on scene and assessed Molina's current state.

OBSERVATION OF DRIVER:

I made contact with the driver who was standing on the sidewalk with Deputy Adnan Raja. Due to a language barrier D/S Raja assisted with translation. The driver was later identified as Juan Camilo Fino Molina by his Florida driver license. During my interview I noticed the driver's eyes were red, watery and glossy and his cheeks were flushed. He was emotional and said he was working and coming from a birthday party. He admitted to having one beer. He swayed while standing. I could smell a strong odor of an unknown alcoholic beverage emanating from his breath that intensified when he spoke. I explained to the driver that I had a suspicion she had been drinking an unspecified amount of unknown alcoholic beverages. Moreover I asked if he would consent to performing Standardized Field Sobriety Evaluations (SFSTs) for the purpose of determining if he was impaired while operating a motor vehicle. He was hesitant in giving consent. I explained the Taylor Warnings and told me his cooperation was voluntary and he had the right not to perform the SFSTs, not withstanding, however, I explained the evidence that I already had against him (Red and glossy eyes, flush cheeks and strong odor of an unknown alcoholic beverages coming from his breath) would be strong basis for him being arrested. He later consented to performing the SFSTs. Prior to his performance I asked if he had any physical problems with his body that would inhibit him from performing light physical movements. I also asked if he was on medication. The defendant conveyed he neither had anything wrong with him physically, nor was he on medication. I escorted him to a smooth and level surface that was free from obstructions and debris. I asked him to identify the white edge line on the shoulder of the roadway. He did so by placing his foot on the line when asked. The area was well illuminated by ambient lighting. The following SFSTs were explained, demonstrated, translated and acknowledged by him prior to his performance: HGN, The Walk and Turn, The One Leg Stand, The Finger to Nose and The Romberg Alphabet Recitation. his deficiencies were noted on another form in this packet.

Through translation defendant admitted to drinking one beer and being at a party.

Strong odor of an unknown alcoholic beverage coming from subject's breath.



Other Observations:

Subject was asked to stand with their feet together and place their hands by their side. They were asked to focus on the stimulus and follow it with their eyes. Lastly they were told not to move their head to assist in following the stimulus with their eyes. Subject swayed from side to side while performing this evaluation.

WALK & TURN:

The def was placed in the instructional stance for the Walk & Turn and given instructions. The def stated that they understood my instructions. Subject swayed while placed in the instructional position. During the evaluation subject did not touch heel to toe, he stepped off the line, he turned improperly (spun in one motion after asking for instructions), took incorrect number of steps.

ONE LEG STAND:

The def was placed in the instructional stance for the One Leg Stand and given instructions. The def stated that they understood my instructions. Subject swayed and leaned while his leg/foot was elevated. Did not raise his foot 4 inches but left it close to the ground. Dropped foot on the roadway on one occasion.

FINGER TO NOSE:

The def was placed in the instructional stance for the Finger to Nose and given instructions. The def stated that they understood my instructions. Subject swayed during this evaluation. Did not touch the tip of his finger to the tip of his nose 4 out of 6 times. Rather he touched the side and underneath his nose.

ROMBERG ALPHABET:

The def was placed in the instructional stance for the Romberg Alphabet and given instructions. The def stated that they understood my instructions. Subject failed to recite the alphabet in Spanish on his first attempt. Completed without flaw on his second attempt.




