

	<p>On Monday, April 30th, 2018 at approximately 9:00 PM, I was traveling west on West Indiantown Rd, east of Maplewood Drive. I was on duty, operating a fully marked Jupiter Police vehicle.</p>							
	<p>At this time, I noticed a white Kawasaki motorcycle pass me traveling east on Indiantown Rd. The driver of the motorcycle was wearing a black helmet, and a grey hoodie. I also noticed that as the motorcycle passed me, it did not have a tag attached to it.</p>							
	<p>Once the motorcycle passed me, it ran the red light on W. Indiantown Rd at Maplewood Dr, and again at W. Indiantown Rd/Center St. The motorcycle also began to "split" lanes, driving in between vehicles that were in separate lanes.</p>							
	<p>I continued to follow the motorcycle traveling west on W. Indiantown Rd. I activated my emergency lights in the area of W. Indiantown Rd and Central Blvd in order to make a traffic stop on the motorcycle.</p>							
	<p>The motorcycle initially slowed down, but then sped up, ultimately getting on the I-95 SB ramp. At this point, I also activated my siren. The operator of the motorcycle had turned around a few times looking in my direction, waving his hand at me as well.</p>							
	<p>The motorcycle again slowed down as if to pull over on the right shoulder, and again on the left shoulder, however it ultimately quickly accelerated, merging on to I-95 SB, traveling in excess of 130 MPH.</p>							
	<p>Just prior to merging onto I-95 SB, I deactivated my emergency lights and siren. The motorcycle continued S/B on I-95 south of Donald Ross Rd. I exited onto Donald Ross Rd as it continued on I-95 SB.</p>							
	<p>I had given NorthComm dispatch a description of the motorcycle and its driver.</p>

Approximately 20 minutes after I had given this information , PBGPD Officer Robert Artola advised he had seen a motorcycle matching the description I had given, along with the driver description I had given, traveling south on Military Trail from PGA Blvd.

Ofc. Artola was able to follow the motorcycle to Lilac St. in PBG, where it turned to head east. As Ofc. Artola continued to look for the motorcycle in this neighborhood; he could smell the distinct odor of burnt fuel and rubber. Moments later, Ofc. Artola located the motorcycle parked in the driveway at 4394 Golfers Circle W. in PBG.

I responded to this address and made contact with Ofc. Artola. He briefed me as to his observations. I, along with MPO Salvemini, and several PBG officers remained outside the residence. I noticed the white Kawasaki motorcycle in the driveway with no tag on it. It looked exactly like the motorcycle that fled on me earlier.

Sgt. LeBlanc from PBGPD knocked on the door to the residence, and a W/M subject (later identified as Charles Gruff, DOB 8/9/92) opened the door. Gruff indicated we were at his residence.


I asked Gruff if the motorcycle in the driveway was his. He said it was not but it was his friends. I asked him where his friend was, and he said inside his (Gruff`s) residence. I asked Gruff if he would ask his friend to step outside. Moments later, a W/M subject (later identified as Juan Jose Trujillo Quintero, DOB 01/01/93) came outside.

Trujillo Quintero was wearing a grey hoodie that looked exactly like the one the subject who fled on the motorcycle was wearing. Based on this, I read Trujillo Quintero his Miranda warnings; however he refused to answer any questions.

I then asked Gruff if there was a helmet inside of his residence. Gruff then went inside and came back outside with a black helmet, which looked exactly like the helmet the subject was wearing who fled from me earlier.

It should also be noted that the motorcycle was warm to the touch and smelled like the burning fluids and tires that Ofc. Artola had described. A VIN check of the motorcycle also showed it was owned by Trujillo Quintero.

Based upon the above facts, I placed Trujillo under arrest for Fleeing and Eluding (High speed and reckless), per FSS 316.1935 (3) (a), in that he willfully fled from a Law Enforcement Officer, in an authorized enforcement patrol vehicle, with agency insignia and other jurisdictional markings, prominently displayed on the vehicle, with lights and sirens activated, and during the course of the fleeing, drove at high speed, and in a manner which demonstrated a wanton disregard for the safety of persons and property.
