PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On the above date and time, I responded to a traffic stop that Cpl Walton #6942 conducted involving a possible impaired driver near the intersection of Roberts Ln / S. Congress Avenue in unincorporated Palm Beach County. Upon arrival, I observed Cpl Walton's vehicle with its emergency lights activated parked behind a yellow Dodge Ram extended cab bearing Florida tag #Y21LSA. Upon exiting my vehicle, I met with Cpl Walton who told me the following which was also provided on a supplemental probable cause affidavit. "While Southbound on Congress Ave just North of 2nd Ave N, I noticed a Yellow Dodge Ram 1500 make a u-turn to go Southbound on Congress ave. The Dodge made such a wide turn the it struck the west side curb. The vehicle then entered the #3 lane Southbound. The vehicle then rubbed the curb to the right several times as seen on my in-car video. I proceeded to follow the vehicle and conducting a computer check of the FL Tag Y21LSA. Dispatch advised me that the vehicle tag was expired on 05/30/2017.

I conducted a traffic stop on the vehicle just South of Melaleuca Lane. The vehicle, as it turned into the parking lot of a motel, made a wide right turn entering into the #2 lane partially before turning into the parking lot.

OBSERVATION OF DRIVER:

I made contact with the Ramos Diaz who was still seated in his pickup truck. I observed Ramos Diaz was wearing blue jean pants and purple shirt. While questioning Ramos Diaz, I observed that he seemed nervous by my questions. I observed Ramos Diaz eyes appeared red and glassy. I observed that he was slurring his words and I detected a strong odor of an unknown alcoholic beverage coming from within his vehicle. Ramos Diaz was asked if he had any alcoholic beverages tonight prior to being stopped. Ramos Diaz advised he had two Apple Orchard beers. While looking into the vehicle, I observed three empty 12 oz apple orchard beers on the rear floor board. Also on the passenger side floor board was a case of Modelo beer bottles which was upside down with beer bottles inside a plastic bag. I asked Ramos Diaz to exit his vehicle to perform field sobriety tasks which he agreed to. While exiting the vehicle, Ramos Diaz appeared to be shaky on his feet.

DRIVER'S STATEMENTS:

I escorted Ramos Diaz to a single white line which I created utilizing a roll of white tape. I proceeded to ask Ramos Diaz if he had been drinking or used any drugs. Ramos Diaz stated he drank two Angry Orchard beers. I asked Ramos Diaz if he had any medical problems and if so what and he advised "none". I then asked Ramos Diaz if he had any previous injuries and if so what. Ramos Diaz advised he did not have any injuries and was only heading home. I then asked Ramos Diaz if he wore any glasses or contacts to correct his vision and Ramos Diaz advised "no". Finally I asked Ramos Diaz if he takes any prescribed medication and if so what is that medication. Ramos Diaz advised he did not take medication. As I spoke to Ramos Diaz, I detected a strong odor of alcoholic beverage coming from his breath.

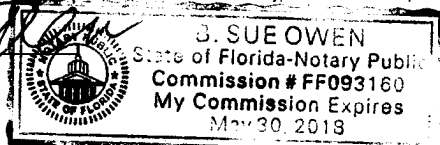

Other Observations:

Once positioned in the front of my vehicle, I confirmed my investigation. I instructed Ramos Diaz to keep his hands by his side, stand with his feet together, and follow a red light with his eyes not turning his head. I asked him if he understood my instructions. Ramos Diaz verbally stated he understood my instructions. Ramos Diaz swayed while standing stationary. I observed both eyes to be red, bloodshot, and glossy. His left and right eye displayed equal pupil size, equal tracking, and a lack of smooth. I observed distinct and sustained nystagmus was present in both his left and right eye at maximum deviation during two separate four second evaluations. The onset of nystagmus was prior to a 45 degree angle in both his left and right eye during two separate four second evaluations. Vertical nystagmus was not present in both the left and right eye during two separate four second evaluations. While conducting the task I had to remind him three times to keep hands to his side, not turn his head, keep both feet together and to follow the stimulus multiple times.

WALK & TURN:

I positioned Ramos Diaz on a solid white line which I created utilizing a roll of white tape. I instructed Ramos Diaz to place his left foot on the line and his right foot in front of the left touching heel to toe. I instructed him that he was to keep his hands at his side and stay in this position until I instructed him to do otherwise. I instructed Ramos Diaz to walk nine heel to toe steps counting out loud, while watching his feet. On the ninth step he was to keep his front foot on the line and use his back foot, in a series of small steps, to turn around before walking nine heel to toe steps the opposite direction counting out loud and watching his feet. I demonstrated the task while I verbally instructed him in the proper way to complete the task. During the task, I observed Ramos Diaz started too soon and was confused by my instructions. I explained the task a total of three times before Ramos Diaz stated he understood. When I asked Ramos Diaz to begin, I observed he swayed while balancing, stopped walking to steady self, stepped off the line three times. While turned Ramos Diaz did not turn properly losing his balance causing him to stagger.

ONE LEG STAND:

I placed Ramos Diaz with his feet together and arms at his side. I demonstrated the task as I verbally instructed him to raise one of his feet approximately six inches off of the ground, point his toe towards me, look at the raised foot, and count out loud until told to stop. I asked him if he understood the instructions and demonstration I provided. During the instruction and demonstration I observed he swayed while standing stationary. He confirmed he understood the instructions and I instructed him to start the task. While raising his foot he maintained it close to the ground under six inches and did not look at his foot. I told Ramos Diaz to lift his foot higher and to keep his eyes on the tip of his foot. Ramos Diaz swayed heavily and used his arms to assist him with balancing. When told to continue to watch his raised foot, Ramos Diaz hopped several times.

FINGER TO NOSE:

I instructed Ramos Diaz to stand with his feet together, make each hand into a fist keeping extended his index fingers and to place his palms facing up. He was instructed to lower his arms to his side. I instructed and demonstrated the proper hand and arm position and for him to remain in this position while I demonstrated the rest of the task. I instructed and demonstrated him to tilt his head back approximately 45 degrees and close his eyes while waiting for a verbal command of left or right. On the command of "left" or "right", he would raise the requested hand, touch the tip of his finger to the tip of his nose, then bring the hand immediately back down to his side. During the instruction and demonstration of the task he swayed while standing in the instructional position. Also while attempting to position him in the instructional stance he separated his feet attempted to regain his balance. Ramos Diaz was asked to place both feet together and if he understood the instructions. Ramos Diaz stated yes and I instructed him to start the task as explained. During the task, I observed Ramos Diaz failed to return arms to side and had to be told verbally to lower his hand back by his side. On the first command of right, Ramos Diaz touched his hip and raised the tip of his finger to the tip of his mouth.

ROMBERG ALPHABET:

I verbally inquired if Ramos Diaz could recite the entire English alphabet. He stated he did not know the alphabet at which time, I asked if he knew how to count to the number 100. Ramos Diaz stated he could count and was ask to stand with both feet together and with his arms by his side and to stay in this position until told to do otherwise. I asked Ramos Diaz to recite the numbers from 1 to 100 in a non-rhythmic manner. I instructed him that upon starting he was to tilt his head back and close his eyes. I asked Ramos Diaz if he understood the instructions and he verbally replied he understood. During the instructions he continued to sway while standing stationary. I instructed him to start the task as explained. During task Ramos Diaz swayed and had difficulty maintaining his eyes closed. Diaz counted each number from 1-100 rapidly not following my instructions to count numbers in a non-rhythmic manner.

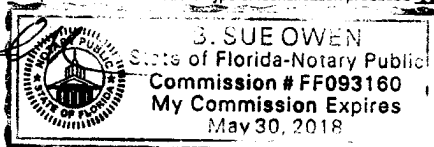
