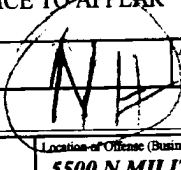

On the 25 day of September, 2019 at 23:55 (Specifically include facts constituting cause for arrest.)

The following incident took place on September 25, 2019 in the City of Boca Raton, Palm Beach County, Florida.

At 2346hrs I observed a black Nissan SUV bearing FL KXYJ23 traveling northbound on N. Military Trl at the 3000 block. The SUV drifted in and out of the right and middle lanes while traveling 10-20mph below the 45mph posted speed limit. When the SUV was approaching the intersection of Yamato Rd, the light turned red and the SUV stopped; upon the light turning green, the SUV had a delayed reaction to the green light. After proceeding through the green light, northbound in the left (inside) lane of Military Trl, the SUV drifted into the middle lane, which was occupied by another vehicle. After witnessing several vehicle-in-motion indicators of impairment as well as a near miss of a crash I initiated a traffic stop on the SUV by activating my overhead lights while driving directly behind the SUV. Before I could activate sirens, the driver of the SUV pulled the SUV over into the left turn lane of 5500 N. Military Trl.

I approached the SUV on the driver's side and spoke with the driver through the open window. The driver identified herself as w/f Judit Kelemen via FL DL K455420555870. There was an obvious odor of an alcoholic beverage emanating from the open driver's window. I asked Judit where she was coming from and if she'd consumed any alcoholic beverages. Judit told me that she was coming from New York Prime and had consumed "two" alcoholic beverages of vodka martini. Judit explained that she consumed one martini at eight o'clock, one at nine o'clock, left New York Prime at eleven o'clock and had only made it as far as the traffic stop. It should be noted that the traffic stop took place at 2349hrs, which is 49 minutes after Judit claimed to have left New York Prime. The location of the traffic stop was 2.7 miles from New York Prime, which according to maps should only take approximately 7 minutes.

Based upon Judit's driving pattern, odor of alcoholic beverage, admission of

consuming vodka, and lack of awareness of time, I asked Judit to exit the SUV and perform Standardized Field Sobriety Tasks (SFSTs). Once Judit was standing away from the SUV, she appeared unsteady on her feet, her eyes were bloodshot and glossy, and the odor of an alcoholic beverage emanated directly from her breath when she spoke.

The first SFST I observed was Horizontal Gaze Nystagmus. Judit swayed about gently even after being asked to stand still. Judit did not keep her head still as she was instructed to. I observed a lack of smooth pursuit in both eye and in both directions. I observed the onset of nystagmus prior to 45 degrees in both eyes and in both directions. I observed distinct and sustained nystagmus at maximum deviation in both eyes and in both directions. I observed both pupils to appear of same size and have equal tracking.


The second SFST I observed was the Walk and Turn. Judit did not maintain the starting position as she was instructed to. Once Judit began the SFST she stepped off of the line, did not count out loud, and took 14-15 steps before she stopped. Judit did not complete any more of the SFST as she was instructed to.

The third SFST I observed was the One Leg Stand. Judit stood on her left foot and placed her right foot back down to the ground at 2 seconds and 22 seconds during the 30 seconds timed by my watch. Judit did not count out loud as she was instructed to.

The fourth SFST I observed was passing time. I instructed Judit to close her eyes, tilt her head back (with her feet together and hands down at her sides) and estimate 30 seconds. Judit estimated 24 seconds.

After witnessing Judit's driving pattern, smelling the odor of an alcoholic beverage emanating from her breath, and observing her SFSTs I had probable cause to arrest her for DUI, a violation of FSS 316.193(1).

While at BRPD Judit refused to provide a breath sample. I read Judit Implied Consent and she still refused to submit a breath sample (DUI citation A6LQ8YE, refusal).

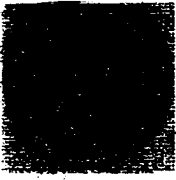

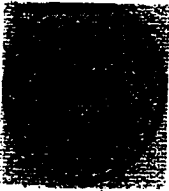

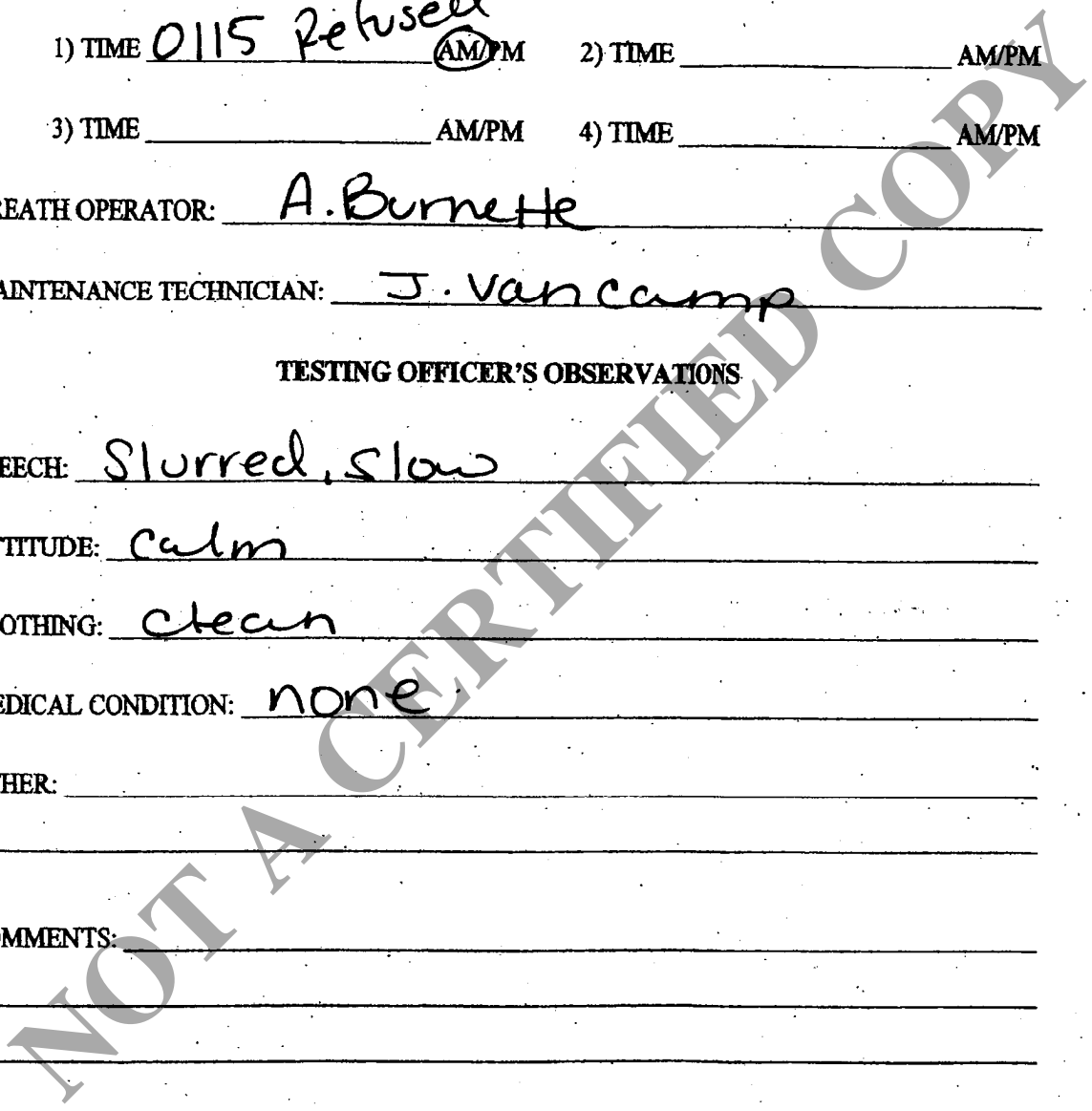
