

The Person taken into custody... committed the below acts in my presence. was observed by _____ that he/she saw the arrested person commit the below acts. confessed to _____ admitting to the below facts. was found to have committed the below acts, resulting from my (described) investigation.

On the **5** day of **September**, **2019** at **04:45** (Specifically include facts constituting cause for arrest.)

On 09/05/2019, at approximately 0445 hours, while being booked into Palm Beach County Jail, 3228 Gun Club Rd, West Palm Beach, FL 33406, reference two DUI charges, two small clear plastic baggies were discovered in Julia Bordieri's (SU) right pocket.

The two baggies had a small amount of a white powdery substance contained within. I asked Bordieri, who had already been read her Miranda Warnings, if the substance was Cocaine, to which she replied "yes". It should be noted Bordieri was aware she was in possession of the substance and made no mention to Officers that she had it on her person. The facility in which the suspected Cocaine was discovered is a clearly labeled detention center, which Bordieri was well aware she was contained within since 0233 hours. Bordieri had already been asked if there was anything this Officer needed to be made aware of, which she declined.

The substance later field tested positive as Cocaine based.

Based on the results of my investigation, I have probable cause to show Julia Bordieri knowingly possessed a Cocaine, in violation of FSS 893.13 and the location which the substance was discovered put her in violation of FSS 951.22(1).

HAND COORDINATION:

Bordieri started the exercise twice prior to being told to begin. On the first set, Bordieri counted "four" prior to touching her fourth finger.

PALM PAT:

Bordieri started the exercise one time prior to being told to begin. On each attempt, Bordieri would open her palm rather than place the rear of her top hand into the palm of her bottom hand. Bordieri only did two rotations then switched hands rather than four as instructed.

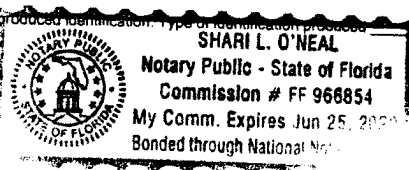

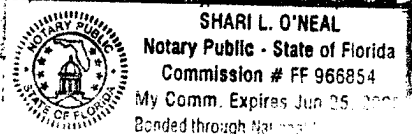
