I responded to the entrance of Victoria Groves development, in the Village of Royal Palm Beach, Fl, in reference to a domestic dispute.

I made contact with the complainant, Felipe Diaz, who said that on 07-18-17, at approx. 9:00 pm, he went over to his girlfriend of 6 months home located at 164 Berenger Walk and then went out to eat dinner. The complainant and suspect, Julia Keys returned home. At this time they both sat in the garage at the above residence drinking wine. The complainant at one point fell asleep in a chair in the garage. Keys apparently picked up his personal cell phone and was checking the victims phone log. Keys found a unknown female friend request on the complainants phone and with that became irate. Keys started to push and shove the complainant. The complainant said that he went to the upstairs part of Keys residence and was trying retrieve a bag of cloth he left there. Keys followed behind him yelling and screaming at him. Keys at one point physically attacked the complainant ripping his shirt off his person and commenced to scratch him. The complainant was not able to retrieve his cloth and was attempting to leave the residence. Keys continued to scratch the complainant on his back, right side of waist and under his right bicep. The complainant left the residence and called for the police.

I could physically see numerous scratch marks on the complainants back, right side and under his right bicep. I noticed a small portion of a ripped T-shirt and the complainants underwear were also ripped. I attempted to make contact with Keys at her residence but she did not answer her door.

Based on the complainants written statement, the physical injuries and the fact that the complainant has been in an intimate relationship for the past 6 months with Keys I believe there is probable cause to arrest and charge Julia Keys with 1ct of Domestic Battery, in violation of F.S.S 784.03(1)(a)(1).
