



On 11/17/17 at 100hrs I conducted a traffic stop on a 2000 black Ford Explorer at 3071 Embarcadero DR for an expired tag, Tag #BHL6700. Expired 05/2017. I made contact with the driver identified as Julian Dibello who was sitting the driver's seat. Dibello was shaking and appeared to be very nervous. I asked Dibello why he was so nervous. Dibello stated his vehicle was not registered and he had drugs in the car. I then removed Dibello from his vehicle. Dibello was handcuffed, double locked and checked for tightness. I then recovered a small baggie containing Marijuana on the floorboard inside a black and mild cigar package. I then recovered a piece of crack cocaine under a crack pipe located in the forward center pocket under the stereo. Dibello stated he just was smoking when I pulled up. Dibello is charged for violation FSS 893.13(6A) Possession of Cocaine and FSS 893.13 (6B) possession of Marijuana under 20grms. Dibello was issued a warning citation for expired tag.
