On the **2** day of **February**, **2018** at **22:50** (Specifically include facts constituting cause for arrest.)

On 02/02/2018 at approximately 2110 hours, Your Affiant was working in a uniformed capacity assigned to the Special Investigations Division (Criminal Apprehension Team), dressed in BDU slacks, exterior vest with bold white lettering of the word POLICE displayed on the front and back while riding in an unmarked West Palm Beach Police Department police vehicle with an exterior shining blue/red light and police sirens. Your Affiant was riding Tandem with Agent Chaves and Agent Flaton.

While conducting proactive patrol, units observed a black 2014 Chevy Cruze bearing Florida Tag Y20SYX illegally parked on the grass of a field in Phipps Park. Units made contact with the vehicle to advise the occupants that the park is closed at sun down. Your Affiant and other units immediately identified ourselves as police officers and approached the vehicle. Upon approach I could immediately smell the sweet pungent odor that I know from my training and experience to be marijuana. While approaching the vehicle the driver of the vehicle threw out what appeared to be a rolled cigarette of marijuana. Contact was made with driver who was identified as Julian Ones (w/m 07/26/1998) via Florida Drivers License. There was a front passenger as well, identified as Amanda Santiago (w/f 08/19/1993). Your Affiant advised Ones that the vehicle was going to be searched due to the smell of Marijuana. I asked Ones if their was any items in the vehicle that he would like to notify police of prior to the search such as narcotics or firearms, Ones said "Xanax bars are in the Center Console." I then looked into the center console and found a large amount of square green bars labeled with a "S|90|3," That I know from my training and experience to be Alprazolam, in a small plastic baggie. After finding the narcotics Ones advised police that a firearm was located underneath the driver seat. Your Affiant then located a black semi automatic Taurus PT740 .40 Caliber pistol (Serial Number SGY43357) underneath the driver seat. Ones was placed into handcuffs secured for proper fit and double locked per agency policy.

It should be noted that a small steel grinder, commonly used to crush marijuana leaves was found in the center console with noticeable marijuana residue left on it. A small digital scale was also found in the center console.

Santiago advised to Your Affiant that she had no knowledge of the narcotics or firearm and she left the scene without incident. Ones was placed in the rear of a marked West Palm Beach Police Vehicle and transported to the Special Investigations Division for furtherance of the investigation.


While at the interview room at the Special Investigation Division, Ones was read his Miranda Warnings using a department issued Miranda Rights Card. Ones signed the card, advising that he fully understood his Miranda Warnings. During the interview, Ones advised that the vehicle is registered to him and that he was aware of the firearm underneath the front driver seat of the vehicle. Ones chose not to speak to police regarding the found Alprazolam. Ones advised that he does not have a prescription for the Alprazolam.

The 36 pills of Alprazolam were weighed to be 10.7 grams and entered into the West Palm Beach Police Evidence Section, along with the marijuana grinder and digital scale. It should be noted that the Alprazolam was found in a plastic baggie and not inside of a proper prescription bottle with proper labels.

An NCIC/FCIC search of the black semi automatic Taurus PT740 .40caliber Pistol (Serial Number SGY43357) revealed that the firearm was stolen during a burglary that occurred in Palm Springs (Palm Springs Police Department Case 2017-19544). The firearm was entered into evidence.

At this time, probable cause exist to place Julian Ones under arrest for violation of Florida State Statute 790.07(2) Possession of a Firearm During the Commission of a Felony, for violation of Florida State Statute 893.13(6) (A) Possession of a Schedule IV substance, for violation of Florida State Statute 499.03(2) Possession of Prescription Drugs without properly labeled container and for violation of Florida State Statute 893.147 Possession of Drug Paraphenellia. Ones was transported to the Palm Beach County Jail without incident.

Sheehan's Towing was notified and a Vehicle Storage Report was completed. The vehicle was towed by Sheehans. Sergeant Hamersma notified of the incident. Department issued body worn camera were utilized during the incident. It should be noted that Ones' cell phone is being held at the West Palm Beach Police Evidence section pending a search warrant for furtherance of the case. At this time, there is nothing further to report.
