




S T A T E M E N T	<p>On December 18, 2016 at approximately 0024hrs, I, Officer Waldkoetter (ID 865) was dispatched and arrived to 402 W. Ocean Ave, Lantana, FL 33462 in reference to an unwanted guest. Upon arrival I made contact with W/M Christopher Doherty (dob 10/04/64) who stated that his girlfriend W/F Julie Godnick-Gruber (dob 9/27/1963) had too much to drink that evening and has been fighting with him and refusing to leave his residence. Christopher and his friend Rick Marcus were in the home with several juveniles at the time. Christopher requested that Julie be given a trespass warning from the property.</p>								
	<p>I made contact with Julie who appeared highly intoxicated and combative. Julie was advised that she must gather her belongings and leave the residence at that time. Chris had already placed all of her belongings in her vehicle in an attempt to expedite her departure. Julie continuously refused to leave and was locking herself in the bedroom with a juvenile sleeping, while intoxicated.</p>								
	<p>I escorted Julie out of the residence and advised her to call for a ride, a taxi or an uber. Julie attempted to call only one person and then demanded that I call her a ride, provide her a ride home or get her an uber because "she paid my salary". I requested dispatch to contact a taxi for her with negative results. While attempting to find her transportation Julie became more combative and aggressive. Julie began cursing at me, screaming profanities, kicking the door of the vehicle and blowing the horn of the car. Julie threatened to spit in my face and refused to comply with my request's. Julie got into her vehicle, after being warned not to drive while intoxicated, started the engine, closed the door, and began to attempt to leave. Officers stopped her from doing so and again she became combative and refused to cooperate or find transportation and exit the property. Julie was placed under arrest for trespass after warning. At this time she became more belligerent and combative. She pulled away from me several times, jerked her arm from me and pushed me away while attempting to search her before placing her in the marked patrol car. While Julie was jerking and shoving she was calling me a</p>

Christopher was taken into custody by another Lantana Officer.</p> <p>Christopher`s friend Rick Marcus (dob 5/07/68) witnessed the entire chain of events beginning with the incidents prior to officers arrival and while officers were on scene.
