

## PERSONAL CONTACT

### DRIVING PATTERN:

Vehicle was traveling southbound at the 500 block of North US Highway 1 within the Village of Tequesta with a rate of speed of 57 mph. Once i activate my emergency lights and siren the vehicle slowed down to approximately 30 mph and came to a very slow and complete stop in the intersection of Old Dixie Highway and Eyeball Avenue.

### OBSERVATION OF DRIVER:

I made contact with the driver (Julie Ryan) and immediately could smell and odor of an unidentified alcoholic substance emanating from Ryan's breath and person. Ryan had slurred and confused speech, he kept saying she was trying to help other people.

### ODORS:

When Ryan spoke, i smelled a strong pungent odor of an unidentified alcoholic substance.



## WALK AND TURN:

During the instructional phase, I advised Ryan to stand with her left foot on the line and her right foot, heel touching toes, with her hands down by his side. Ryan requested that she take off her sandals for the task and I stated absolutely. Ryan could not keep her right foot in front of her left and instead, she went to a normal stance and had to be told to stand in the beginning position. Ryan began the task and touched heel to toe on step 1, 2, and 3. After that she never touched heel to toe. Ryan turned incorrectly. Ryan again touched heel to toe on the first 3 steps and then did not touch on the last 6.

## ONE LEG STAND:

During the one leg stand I explained and demonstrated the task to Ryan and she stated she understood. Ryan began with her left foot and counted 1001, 1002, 1003, 1004, 1005, then stepped for balance and said "See I can't do it, it's too hard." I stated that it was ok and she can try again. Ryan asked if she could use her right foot. Ryan picked her foot up above 6 inches and was approximately at 10 inches. Ryan began counting: 1001-1009, then counted 10,000, then 11,12,13,14,15,16,17,18,19,20. I stopped the task.
