**On Wednesday 06/28/17 approximately 1325 hours, I participated in a prostitution operation located in the area of the 2600 block of S. Military Trail, unincorporated Palm Beach County, Florida, due to increased complaints of street level prostitution. The locations were chosen due to recent citizen's complaints and arrests reference prostitution activity.**

**[REDACTED] was a 'decoy' posing as a [REDACTED] and was driving an unmarked PBSO assigned vehicle. [REDACTED] made contact with an Asian female, later identified as Juliette Humphries, at 2600 block of S. Military Trail. [REDACTED] asked Humphries if she was working in which Humphries replied yes and entered [REDACTED] vehicle.**

**A conversation ensued in which Humphries agreed to a "Appetizer" for \$45.00, which is street terminology for oral sex. The conversation continued in which Humphries agreed to a "Full Meal" for \$60.00, which is street terminology for sex.**

**Once [REDACTED] was given that [REDACTED] established probable cause, [REDACTED] and I conducted a traffic stop which terminated at the south side of the plaza located on Cresthaven Blvd. west of S. Military Trail. Humphries was taken into custody without incident.**

**Humphries was placed into flexcuffs checking for tightness and proper fit as per PBSO policy without incident. Humphries was transported to a predetermined area where paperwork was completed. The incident was captured [REDACTED] for trial purposes which was turned into evidence.**

**Based on the above facts, there is probable cause to charge the Defendant with Violation of FSS 796.07(2) (F) Offer to Commit Prostitution. The defendant was later transported to the Palm Beach County Jail. This case is cleared by arrest.**
