

On 6/30/17 around 1815 hours, I responded to the PBSO headquarters lobby in reference to a delayed domestic battery incident originating from 4406 Country Grove Blvd in unincorporated West Palm Beach, Palm Beach County Florida 33406.

Upon my arrival, I met with Jocelyn Campos, who verbally identified herself. Jocelyn told me the following: in the early morning hours of 6/30/17, she got home from work and went to sleep in the bed with her mother (Lizabeth Campos), stepfather (Julio Lopez Angulano), and sister (Jackelyn Lopez). Jocelyn slept at the foot of the bed facing away from the headboard, as the other three slept with their feet towards Jocelyn's back. Around 0300 hours, Jocelyn woke up to Julio rubbing her back with his feet. He then grabbed her hand, and placed it over his boxer shorts, forcing her to touch his erect penis against her will. She pulled her hand away, and waited for him to fall asleep before she left the bedroom and went into her bedroom.

As I spoke to Jocelyn, I observed she was visibly upset and fearful. She took several pauses to regain her composure. She was emotional, and paused at times to cry as she told me what happened. She appeared sincere and candid as she told me what happened. Jocelyn gave me a sworn written statement about what happened.

I relocated to 3402 Lakeville Circle, and met with Julio, who identified himself via his Florida Driver's License. Julio agreed to speak to me while standing in front of my patrol car with his actions video and audio recorded. I read Julio his miranda rights from a PBSO issued miranda card. Julio signed the card and gave me verbal confirmation that he understood his rights. Post miranda, Julio initially denied touching Jocelyn. When interviewed further, Julio agreed to be completely honest with me, and he admitted that he grabbed Jocelyn's hand, and placed it on his penis while the two were in bed together. Julio told me it was a one time mistake and seemed apologetic for his actions.

Based on my investigation I found Julio Lopez-Anguiano to be in violation of FSS 784.03(1)(a)(1) Domestic Battery.
