WALK & TURN:

The driver had issues getting into the instructional position. The driver did not remain in the instructional position as instructed. I observed the driver to sway while the instructions were being given, miss heel to toe and step off the line during the task. The driver raised his arms for balance and placed them behind his back, turned incorrectly and took the incorrect number of steps. The driver did not count his steps aloud. The driver did not make heel to toe contact. The driver also asked questions during the task.

ONE LEG STAND:

I observed the driver to sway while in the instructional position. The driver failed to remain in the instructional position. The driver stated he could not continue with the task.

FINGER TO NOSE:

The driver failed to get into the instructional position and had issues maintaining the instructional position. The driver failed to tilt his head back after being instructed to do so and close his eyes. The driver failed to touch the tip of his finger to the tip of his nose. All attempts the fingers touched the area above the tip of the nose or on his lips. The driver raised each instructed hand in the air and held it there. I had to remind the driver to touch his nose. The driver failed to bring his finger down to his side after as per instructed. The driver did raise the correct hand every attempt when instructed to do so.

ROMBERG/ALPHABET:

The driver had issues getting in the instructional position as instructed. The driver started the task before instructed to do so by reciting them under his breath. The driver was instructed to recite the alphabet from A to Z. The driver recited the alphabet in a fast manner incorrectly. When instructed to recite in a slow manner the driver failed to recite it correctly.




