

On arrival, I made contact with Justin Eugene Staer (DOB: 12/21/1989) who I saw leaving the residence in a 2005 Blue Dodge Durango bearing FL temporary tag BWA4604.</p>											
<p>I saw the vehicle back up from the residence driveway and drive toward my direction. I activated my overhead (red and blue) police lights and Justin pulled into a driveway. Justin exited the vehicle and began to spontaneous utter that his mother called him and told him that his nephew, Braden, was being assaulted in some manner by his step-dad Michael Allen Seamon (DOB: 11/05/1988).</p>											
<p>Justin stated he was fed up with hearing the accusations and wanted to confront Michael. I read Justin his Miranda Rights from my issued Palm Beach Gardens Miranda card and asked him what happened. Justin acknowledged his rights and stated he showed up the residence to confront Michael. Michael exited the house and words were exchanged between the two. Michael went back inside the house and would not come back out.</p>											
<p>Officer Tiyaloglu made contact with Michael, who lives at the above mentioned address. Michael provided a sworn statement via body camera. Michael showed Officer Tiyaloglu text messages from Justin's sister (Lisa Marie Coates, DOB: 08/29/1984) to him stating that Justin was on the way over to their house to confront him. Michael stated he came outside of the residence to confront Justin. The two exchanged words amongst each other and Michael went back inside the residence. When Michael went back into the residence he stated Justin threw a stepping stone from the front of the house into the front window of the residence causing the window to shatter. Michael stated Justin did not try to make any entry into the residence he just threw the stone into the house causing the window to shatter and break. The window is estimated to be valued at \$200.00. Michael</p>


