


On 5/23/2017, at 02:22AM, I was dispatched to 15848 129TH PL North, in the unincorporated area of Jupiter, in Palm Beach County Florida, to investigate a suspicious incident. Prior to my arrival, Palm Beach County Sheriff's Office dispatch advised that they received a 911 call stating that a female was yelling and stating that she was bleeding from her eyebrow. Upon my arrival, I observed a white female and a white male running towards the back of 15848 129th PL North with the white male behind the female. I then was able to make contact with the white female in the front of 15848 129th PL North and later identified her as Laura Breinig, date of birth-4/17/1998. Laura had what appeared blood splatter on the front and back of her gray shirt. Laura's nose had what appeared blood pouring out of her nose with dried blood around her lips. I noticed bruising under Laura's right armpit. I then asked Laura what happened and she was having trouble speaking and was crying. The white male that was behind her then walked up to the front yard and I noticed that he was only wearing underwear, which were ripped. The white male had blood and what appeared a cut on his left eye brow. I then identified the white male was Justin Gilbert, date of birth-11/13/1993. Laura advised me the following:
 Justin is her current boyfriend, which Laura has been sexually active with Justin within the past 6 months. Justin came home a couple of hours ago and was intoxicated. Laura was upset that he came home intoxicated and wanted him to leave. Justin then laid down on the couch and at some point Laura was grabbed by Justin and thrown all around the house by Justin. Justin would grab on the back of Laura's neck and pull her into multiple rooms and finally throwing her on the couch. Laura then started to push off of Justin striking him in the face at some point and pulling on his boxers to break his grip on her. Laura was then punched in the face by Justin and when Laura advised Justin that she was calling 911 to notify police, Justin took her phone from her and hid it. Justin then locked Laura out of the house and police arrived shortly after.
 I then spoke with Justin and he advised me the following:
 Laura punched him in the face and was the aggressor. While he was laying down and sleeping, Laura attacked him and ripped his dick.
 I then spoke with a neighbor who was Mathew Zaragoza, date of birth- 8-13-1973, who resides on the same property (15848 129th PL North) in a separate house on the West side. Mathew stated that he was woken up by his family and told that a female was yelling for help outside. Mathew never witnessed anything.
 Probable cause exists for the arrest of Justin Gilbert for violation of Florida State Statute 784.03 (1a1) Simple Battery "Domestic" and Florida State Statute 914.22 (1E) Witness Tampering/Depriving use of 911
