On the <u>10</u> day of <u>May</u>, <u>2019</u> at <u>14:28</u> (Specifically include facts constituting cause for arrest.) The following incident occurred in the City of Delray Beach, Palm Beach County, FL: On May 10, 2019 at approximately 1428 hours, Sgt DeBree, Ofc Sargent, Ofc DeFranco, and I were conducting an operation at Home Depot, 1400 Waterford Pl, due to retail thefts. While conducting the operation, DBPD Communications advised PGA Tour Superstore, 1040 W Linton Blvd, had a subject who was suspected of concealing items in his pants. Due to this, we went to PGA Tour Superstore's parking lot and waited for the white male suspect to exit the store. The suspect, later identified as Justin Barr via FL DL, later exited the store and went to his black Toyota 4Runner, bearing FL tag HLN5F. Sgt DeBree, Ofc Sargent, Ofc DeFranco, and I made contact in our full police uniforms with Barr. Barr's pants had bulges on each of his upper leg area. Sgt DeBree patted Barr down for our safety and then advised Barr to remove the items he stole from PGA Tour Superstore. Barr removed a polo shirt valuing \$65, a polo shirt valuing \$85, a golf glove valuing \$24.99, and socks valuing \$21.99; a total of \$196.98. Ofc Sargent then spoke with PGA Tour Superstore manager Vachelle Byron. Byron advised all the products in Barr's pants were from their store and were not paid for. While doing an inventory of Barr's vehicle, Ofc DeFranco located a Callaway golf club still in the package with the anti-theft device removed. Ofc DeFranco then spoke with Byron who stated the golf club belonged to them and was stolen from their inventory. The club had PGA Tour Superstore barcode on the packaging and the anti-theft device that was removed was in the same place PGA Tour Superstore places them. The golf club is valued at \$299.99. Due to the above, Probable Cause exist to charge Justin Barr with two (2) counts of Retail Theft, pursuant to FSS 812.015(1)(D).
