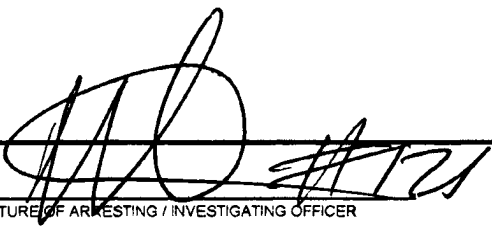

On Saturday, July 13, 2019 at approximately 2150 hours I was dispatched to City Place located at 700 S Rosemary Ave. in reference to an intoxicated male causing a disturbance. The incident was reported by the overtime Cityplace Officer Eick. Upon arrival, this writer made contact with Det. Viteri who advised the following facts. The intoxicated male, identified as Justin Hamilton Kleckner (W/M DOB 05/10/1986), was causing a disturbance near City Cellar which is located in City Place. Kleckner was asked to leave the property multiple times by the PSC security director, Roberto Portez and by Cityplace overtime detail officers. The male was observed causing a disturbance and yelling at pedestrians walking by and other patrons of City Cellar. Due to Kleckner's irate and unwelcoming behavior, a crowd had formed behind the officers as he was then disturbing the peace. Kleckner was asked to leave the property multiple times by WPBPD Officers at the request of City Place property manager. Mr. Kleckner refused every time. City Place property manager called and paid for an UBER ride to take Mr. Kleckner home in Fort Lauderdale. UBER arrived and Mr. Kleckner was escorted into the back seat of the vehicle. Mr. Kleckner was given a chance to go home without incident. Approximately 10 minutes later, UBER drove back to City Place and explained that Mr. Kleckner was acting belligerent inside of the vehicle. Mr. Kleckner was spitting and yelling. UBER driver did not feel safe nor comfortable taking Mr. Kleckner home in Fort Lauderdale. Again, WPBPD officers advised Mr. Kleckner that he was to leave the premises and go home and refused. Mr. Kleckner repeatedly asked to keep drinking. Due to Kleckner's erratic, belligerent and heavily intoxicated behavior along with his refusal to cooperate with officers requests, Kleckner was placed into handcuffs, arrested and escorted to WPBPD marked patrol vehicle.
