PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I observed the defendant occupying the driver seat of a gray Ford Fusion bearing Florida tag #BBHL19 for approximately 10 minutes with the vehicle stopped while in drive at the stop sign located in the north entrance of Embassy Suites parking lot which is located at 4350 PGA Boulevard in the city of Palm Beach Gardens, Palm Beach County, Florida. The vehicle was turned on at the time of this traffic stop with the keys still inside of the ignition.

OBSERVATION OF DRIVER:

I observed the defendant to be unaware of his surroundings, and to be confused. The defendant's eyes were glassy and red. The defendant had difficulty producing the required documents to drive in the state of Florida. The defendant continued to search for his second cell phone, however the cell phone the defendant was searching for was in plain view in the front center portion of the vehicle underneath the radio uncovered.

DRIVER'S STATEMENTS:

The defendant initially stated he only consumed 3 vodka drinks, then the defendant stated he had 5 vodka drinks. Upon reaching county jail the defendant stated he had 3 vodka drinks, and 3 beers. The defendant stated he was headed home which is located in Lake Worth, Florida.

ODORS:

I could smell a strong odor of an unknown alcoholic beverage emanating from the defendant's breath/person.

GENERAL OBSERVATIONS

SPEECH: slurred speech, unable to complete sentences, mumbles, repeated phrases, repeated questions.

ATTITUDE: Calm, slightly agitated

CLOTHING: Red and white plaid long sleeve button down shirt, black long pants, black shoes.

MEDICAL/OTHER: Defendant advised no medical conditions, or issues.


