# D.U.I. PROBABLE CAUSE AFFIDAVIT

## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 11/9/17 at 2:13 p.m. Palm Beach Gardens Police dispatch advised of a reckless driver. Dispatch stated a white Chrysler minivan bearing Florida tag CICD64, was swerving northbound on 195. The caller, Diane Baker, provided a sworn statement to Officer Diaz, and stated that the minivan was in the HOV lane and swerved to the right causing vehicles to change lanes to avoid collisions. The minivan did this several times before exiting at Donald Ross Road. The minivan pulled into the Shell Gas station and sat at pump 13 with the driver, white male, sitting inside. Baker sat and watched the male driver in the car until Officer Diaz arrived on scene.

## OBSERVATION OF DRIVER:

Officer Diaz arrived on scene and the white male driver and sole occupant exited the vehicle. The driver was identified by the photograph on his Florida license as Justin Seth Crane. I arrived on scene and I made contact with Crane. While speaking with Crane I smelled the odor of an unknown alcoholic beverage coming from his breath as he spoke, his speech was slurred, his eyes were red and glassy, he was unsteady on his feet, swaying entire time.

\*Inventory of his vehicle inside his baseball bag with his shoes was a glass marijuana pipe\*\*

## DRIVER'S STATEMENTS:

driver advised he had some alcohol with Sudafed. Driver stated after I put the handcuffs on that he needed this and that he will get the help he needs

## ODORS:

odor of an unknown alcoholic beverage coming from his breath as he spoke

ATTITUDE: cooperative

CLOTHING: blue shirt, blue jeans, brown boots

MEDICAL/OTHER: stated on scene he has back issues



was swaying, kept moving head, had almost immediate onset of nystagmus, no vertical gaze observed

was unable to hold stance during instructions, had him take his boots off, started once before instructed, used starting stance as step 1, took 9 steps, counted to 10, missed heel to toe several times, stopped and spun around not as instructed, took 9 steps missing heel to toe several times and fell into his vehicle once.

ONE LEG STAND:

demonstrated and explained he said he gets headaches which cause him to have balance issues, I asked him if he has a headache now and he indicated that he does not. Started several times before told to. barely had foot off the ground, put foot down once and stopped before I instructed him to.

FINGER TO NOSE:

demonstrated and explained he said he understood and knows the difference between his left and right. was swaying entire time, started before told to, used correct hand each time started to use wrong hand once, touched top of nose each time.

ROMBERG/ALPHABET:

demonstrated and explained he said he knows the alphabet and has a high school education. was swaying and started before instructed to, did not recite alphabet correctly, said z twice, opened eyes once during task, repeated and skipped several letters
