<p>On April 28, 2017 I was working in an off duty capacity in full uniform for the City of West Palm Beach Police Department assigned to the 300-block of Clematis Street. At approximately 0248 hours, a subject later identified as Justin Ferro was asked to leave Nico's Pizza restaurant by both the manager on duty and police on scene.</p> <p>Ferro became upset and belligerent. His eyes were glassy and bloodshot, his clothing disheveled, and he had a strong odor of an alcoholic beverage emanating from his person. Ferro appeared to be intoxicated, and screamed loudly "Fuck you!" several times as he walked away down the sidewalk.</p> <p>From a distance Ferro continued to scream obscenities at officers and give the middle finger gesture in our direction for several minutes. A crowd was forming on the sidewalk because of the public disturbance created by Ferro's behavior. He was warned several times not to return to the restaurant and even a passerby tried to get him to leave.</p> <p>Ferro came back to the restaurant front door area under a Nico's Pizza restaurant awning where he was taken into custody after a brief struggle.</p> <p>Based on the above information and investigation conducted, probable cause exists to charge Justin Ferro with Trespass After Warning as per FSS 810.08(1) and Disorderly Intoxication as per FSS 856.011.</p>
