Sergeant Immler noticed that the light which illuminates the license plate was inoperable, causing the license plate to be extremely difficult to read. Due to the tag light not being illuminated, Sergeant Immler was unable to correctly read the tag initially when attempting to conduct a registration check. Once a traffic stop was initiated for the equipment violation, Sergeant Immler made contact with the driver, W/M Aaron Rejman. Officer Finne responded to the scene as the initial backup officer. Once on scene Officer Finne advised that he could smell the odor of marijuana emanating from the vehicle. It was at this time that I arrived on scene and assumed command of the investigation.</p> <p>Upon arrival I noted that seated in the front passenger seat was a male identified as Dennis Thompson. Seated in the back seat was a female later identified as Kaela Goodsell.</p> <p>I requested Rejman exit the vehicle and apprised him of our observations. I asked if there was any contraband in the vehicle and he advised there was marijuana within. I then searched his person for contraband with negative results. I then requested Thompson exit the vehicle. I searched him for contraband but none was located. Lastly, Goodsell exited the vehicle. As she exited, Goodsell advised there was a small amount of marijuana in her backpack. Officer H. Leinonen arrived shortly after to search Goodsell for contraband, but none was located on her person.</p> <p>While I searched the vehicle, Officer Finne read all three subjects their Constitutional Miranda warnings. All three subjects advised they understood.</p> <p>According to Rejman, in the center console area of the vehicle, there was a compartment</p>

that contained a vaporizer pen and two ampoules of marijuana oil. I searched the vehicle and located the compartment. Within the compartment was an orange grinder, a clear vaporizer pen and two plastic containers labeled Gold Extracts Supreme Quality Nug Run. Within the package was a clear ampoule containing a clear green oil substance. Note, the package also indicated the substance had 93.7 percent THC. I presented what I located to Rejman. He advised the substance was marijuana and it belonged to him.

I continued to search the vehicle and located Goodsell's green backpack. Within the front pocket of the backpack was a clear plastic baggie containing a green leafy substance I identified as marijuana. I also located rolling papers within the same pocket. I presented my findings to Goodsell and she advised the substance was marijuana and she utilized the rolling papers to smoke the marijuana.

I searched to remainder of the vehicle for additional contraband but none was located.

I field-tested the marijuana with a Quick Check test kit (one use only). The field test was positive for THC by turning purple. I placed the marijuana on a digital scale. The total weight was 2.9 grams. The marijuana and rolling papers were subsequently submitted into evidence. The substance within the ampoule was tested with a field test kit. The contents turned purple confirming the presence of THC. The ampoules were weighed on a digital scale. The total weight was 9.1. The oil and paraphernalia was submitted into evidence.

Based on the above information, I placed Kaela Goodsell under arrest for possession of marijuana less than 20 grams, in violation of Florida state statute 893.13(6b) and possession of paraphernalia in violation of Florida State Statute 893.147. Aaron Rejman was placed under for the marijuana oil in violation of Florida State Statute 893.13(6a) and possession of paraphernalia in violation of Florida State Statute 893.147. Both Rejman and Goodsell was transported to the Boca Raton Police Department for processing and later transported to the Palm Beach County Jail.

Rejman was given a warning for the equipment violation.
