*****SUPPLEMENTAL PROBABLE CAUSE AFFIDAVIT*****

On the above date and time, I responded to 1454 Fairway Cir in reference to a follow-up investigation for a hit and run crash. I was dispatched to this address due to the victim recording the suspect vehicle's tag. The registered owner of this vehicle, W/F Kaitlyn Kanafani, resides at the above listed address.

Upon my arrival, I observed the suspect vehicle (Blue Infinity 4-door bearing FL tag ISFP50) parked in the driveway of the house. I observed minor damage to the front left bumper and fender area of the car, which is consistent with the damage described by the victim. I could clearly see that the front bumper area was wiped clean due to the front bumper being completely clear and the rest of the of the vehicle was covered in dust.

I made multiple attempt to make contact at the residence, but all met with negative results. As I was preparing to leave, W/F Kaitlin Kanfani exited the home. I asked if Kanafani was recently driving the blue Infinity. She said that she was. I then asked if she was involved in an accident. She initially told me that she was not in an accident at all. I asked where the minor damage on the vehicle came from, she began saying that, "Everybody was fine" and nobody needed to call the police. I again asked if she was involved in a crash, to which she responded that she had no damage on her car. Kanafani then changed her story to say that she was not in a crash at all.

I spoke with D/S Gomez #24984 who informed me that the driver of the other vehicle could identify the hit and run driver. I asked him to bring the other party to my location for a show-up. I told Kanafani that I had the other driver on their way to see if she was the hit and run driver. I asked her to sit on the back of her mother's car, which was parked in the driveway. Kanafani responded by telling me no and that she was going inside her house. I toldher that was not allowed to go inside of her house and that she was detained due to being the suspect of a hit and run crash. Kanafani refused to move and kept stating that she was going inside and it was her right to go inside. I asked her multiple times to lean up against the vehicle and every time she refused. Kanafani then started walking away and attempted to get into the house. I grabbed her right wrist and put one handcuff on it to keep her from leaving the area. She began screaming and pulled her arm away from me. She slipped the cuff that I already applied. I quickly grabbed her right wrist again and re-applied the handcuff. She again slipped the cuff while pulling away from me and attempting to get inside her home. I grabbed her right wrist a third time and re-applied the handcuff, making sure I tightened it enough for her not to slip it again. She then proceeded to punch me in the chest because she could not get the handcuff off. At that time, her mother came outside and helped me calm Kanafani down enough to apply the handcuffs to left wrist.
