

911 CALL INTO TEQUESTA POLICE FOR A RECKLESS DRIVER DRIVING SOUTH IN THE NORTHBOUND LANE OF US HWY-1 WITHIN THE CONFINES OF THE VILLAGE OF TEQUESTA.

OBSERVATION OF DRIVER:

WHEN HAVING GOLEC PROVIDE HIS LICENSE, REGISTRATION AND INSURANCE, HIS EYES WERE WATERY AND BLOODSHOT AND DILATED AS HE LOOKED AT ME AND EXPLAINED THAT HE WAS COMING FROM STUART FROM THE BOWLING ALLEY. GOLEC WAS UNEASY ON HIS FEET WHILE HE ATTEMPTED TO SIT DOWN.



CAN NOT DO, WHY?

WALK AND TURN:

ON THE WALK AND TURN, GOLEC DID NOT KEEP HIS BALANCE WHILE REMAINING IN HEEL TO TOE FASHION BEFORE PERFORMING THE TASK. ON STEPS 5-8, KALEB DID NOT WALK IN HEEL TO TOE MANNER. ON STEP 9, KALEB DID NOT SAY "9" OUT LOUD. DURING HIS TURN, KALEB DID NOT MAINTAIN ON THE LINE WHILE PERFORMING SMALL CHOPPY STEPS. ON THE WALK BACK, STEPS 6-9 KALEB DID NOT WALK IN A HEEL TO TOE MANNER.

CAN NOT DO, WHY?

ONE LEG STAND:

DURING THIS TASK GOLEC STATED HE UNDERSTOOD THE TASK, AND WAS ADVISED TO BEGIN. GOLEC CHOSE TO RAISE HIS RIGHT FOOT WHILE PERFORMING THIS TASK. WHILE COUNTING OUT LOAD, GOLEC FAILED TO MAINTAIN BALANCE AFTER "3 ONE THOUSAND" AND PLACED HIS RIGHT FOOT BACK DOWN ON THE PAVEMENT. AFTER LOSING BALANCE ON STEP 4, KALEB RAISED HIS ARMS TOWARDS HIS CHEST TO MAINTAIN BALANCE. ON "5 ONE THOUSAND" KALEB PLACED HIS RIGHT FOOT BACK DOWN ON THE PAVEMENT. AFTER "5 ONE THOUSAND" KALEB RESTARTED THIS TASK ON HIS OWN. WHILE COUNTING AGAIN, ON "7 ONE THOUSAND THROUGH 9 ONE THOUSAND" KALEB SWAYED IN AN ORBITAL MOTION, WHILE RAISING HIS ARMS TO MAINTAIN BALANCE. AT THIS TIME, KALEB STATED HE WAS SORRY AND STOPPED THIS TASK ON HIS OWN.

FINGER TO NOSE:

BEFORE THIS TASK, GOLEC STATED HE UNDERSTOOD THIS TASK. DURING THE ENTIRE TASK, GOLEC REMAINED WITH HIS HEAD NOT TILTED ALL THE WAY BACK, AND REMAINED WITH HIS EYES OPEN. DURING HIS FIRST LEFT COMMAND, GOLEC FAILED TO TOUCH HIS LEFT FINGERTIP TO THE TIP OF HIS NOSE. ON THE SECOND " RIGHT RIGHT" COMMAND, GOLEC STARTED SWAYING IN AN ORBITAL MOTION WHILE HE SPREAD HIS FEET APART TO MAINTAIN HIS BALANCE.

ROMBERG / ALPHABET:

BEFORE THIS TASK, GOLEC STATED HE UNDERSTOOD THIS TASK. WHILE PERFORMING THIS TASK, GOLEC STATED IN A NON RHYTHMIC MANNER UNTIL HE BEGAN TO SWAY AT LETTER "L-R". WHEN GOLEC STATED LETTER "T", GOLEC THEN STATED LETTER "C", THEN "S" THEN "O". WHEN GOLEC APPROACHED LETTER "Q", GOLEC RESTARTED THE ALPHABET AND ENDED ON THE LETTER "L". GOLEC THEN STATED " IM SORRY " AND STOPPED THIS TASK ON HIS OWN.



Additionally, if you refuse to submit to the test I have requested of you and if your driving privilege has been previously suspended for a prior refusal to submit to a lawful test of your breath, urine or blood, you will be committing a misdemeanor. Refusal to submit to the test I have requested of you is admissible into evidence in any criminal proceeding.


