# D.U.I. PROBABLE CAUSE AFFIDAVIT

## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On the above date at approximately 02:56hrs, I was dispatched to the scene of a motor vehicle crash with injuries at 1215 Federal Hwy, which is located in the Town of Lake Park, Palm Beach County, Florida.

I arrived at the scene at approximately 03:17hrs. After my independent crash investigation, based on physical evidence, and witness statements, I determined that, at approximately 02:30hrs, the defendant, "Kaley Renee Lyons", did indeed drive off the road and crash into a pole, a palm tree and two parked cars at the Earl Stewart Toyota Dealership. (See PBSO crash case #18-040943)

Witnesses, identified the defendant, to me, as the driver, of the 2011 white Hyundai bearing Florida tag HHR-T28 at the time of the crash. Witnesses completed a sworn video recorded statement as to the events which transpired surrounding the crash.

D/S Eric Duvaul #19467 relayed to me that Lyons had articulable indicators of impairment, so he called for a DUI Unit to conduct a possible DUI investigation.

## OBSERVATION OF DRIVER:

Upon making contact with the driver at St. Mary's Hospital, she was identified by her Florida driver license as 'KALEY RENEE LYONS', I immediately detected an obvious and strong odor of an unknown alcoholic beverage emitting from her person and face area. This odor intensified as I spoke to Lyons. Lyons had glassy, glazed, and blood shot eyes. Lyons' speech was slurred, slow, thick, and at times difficult to understand. Lyons' movements were slow and deliberate, and lethargic. Lyons had difficulty following directions given to her. Lyons was extremely emotional and would have mood swings. Lyons was wearing a maroon shirt, blue leggings, and blue slippers. All the clothing appeared dirty, disheveled, and torn.

## DRIVER'S STATEMENTS:

Pre-Miranda: Lyons stated she had a couple of beers while out with her mother. Post Miranda, Lyons made admissions that she was driving after having 2 beers and was involved in an accident.

Lyons refused to submit a blood sample after Implied Consent, which she stated that she understood.

## ODORS:

A strong and obvious odor of an unknown alcoholic beverage was emitting from her person and face area which intensified as I spoke to Lyons.

## GENERAL OBSERVATIONS

SPEECH: Lyons' speech was slurred, slow, and thick, and at times difficult to understand.

ATTITUDE: indifferent, emotional, annoyed, argumentative, belligerent, mood swings

CLOTHING: maroon shirt, blue leggings, and blue slippers

Lyons was reminded numerous times to track the pen with her eyes only. Lyons failed to keep her head still while tracking the stimulus. Lyons had VGN and LOC was not present.






