	N A R R A T I V E			

Troy told me that he and his family had just returned home from an escape room adventure. He told me that he had been arguing with Kalie throughout the night and that it escalated once they returned home. Once inside the house, the two continued yelling at each other. Troy told Kalie that he wanted his metal Yeti cup back. They were standing roughly 10-12 feet from each other in the foyer of the home. Troy advised that Kalie threw the Yeti cup full of wine at him. The cup struck Troy in the left leg and caused a laceration. Troy told me that he was angry that Kalie hit him with the cup and he was unsure if she was going to follow up with strikes. Troy then rushed towards Kalie and knocked her over. Kalie fell backwards and tumbled. Her nose was injured in the process. Troy told me that he did not mean to hurt Kalie and reacted almost immediately after being struck with the cup. It should be noted that I observed the Yeti cup still on the ground in the foyer area and there was a red liquid, possibly red wine spilled on the ground. Troy refused medical attention. Photographs were taken of his injury and they were uploaded into evidence.

I then met with Laura Butcher, who is the mother of Troy and Kalie. She told me that Troy and Kalie had been arguing the whole night and that it escalated once they got to the house. Laura advised that Kalie threw a Yeti cup at Troy. Laura told me that she knew the cup hit Troy but she was unsure where on his body that he was hit. Laura then told me that Troy almost instantly charged towards Kalie and knocked her to the ground. Kalie tumbled and went into the bathroom and both parties separated.

Also present on this night was Troy and Kalie's brother, Derek Butcher. Derek told me that he observed Troy and Kalie arguing all night. He then went upstairs once they returned home. He told me that he heard the two of them yelling and then heard Kalie cry. He did not witness the physical altercation.

Lastly, I met with Kalie. She was visibly upset and also had redness and a bump on her nose. I smelled a strong odor of alcohol emanating from Kalie's breath and she told me that she had been drinking wine throughout the night. Kalie told me that she had been arguing with Troy the entire night and that she felt as if she was being verbally abused. Kalie told me that Troy continued to agitate her once the family returned home from the escape room. Once inside the home, she told me that she threw Troy's Yeti cup at him. She advised that she was trying to hit him but didn't think that actually did strike him with the cup. Kalie then told me that Troy ran towards her full speed and knocked her into the wall. Kalie then fell to the ground and her nose was in pain. Kalie locked herself in the bathroom and then called 911. It should be noted that Kalie told me that Troy charged at her and then pushed her almost instantly after she threw the cup at him. Kalie refused medical attention on scene. Photographs were taken of Kalie's injuries and uploaded into evidence.

Based on my investigation, Kalie was the primary aggressor in this incident. According to all parties present during the physical altercation, Kalie initiated the physicality by throwing the cup at Troy. Immediately after being struck with the cup, Troy ran at Kalie and pushed her. According to all accounts, this reaction was almost immediate and a continuation of the cup throwing. I placed Kalie under arrest for simple battery (domestic) and she is being charged under FSS 784.03(1A1). Troy was given an agency Dating and Domestic Violence Rights and Remedies packet from Officer McQuiston. A receipt of the packet was placed in the road patrol bin at the Boca Raton Police Department.
