## PERSONAL CONTACT

### DRIVING PATTERN:

I OBSERVED A DARK PICKUP TRUCK, TRAVELING AT A HIGH RATE OF SPEED NORTHBOUND ON OLD DIXIE HIGHWAY AT THE LOCATION OF 221 OLD DIXIE HIGHWAY, WITHIN THE CONFINES OF THE VILLAGE OF TEQUESTA. I VISUALLY ESTIMATED THE SPEED OF THE VEHICLE TO BE AROUND 50 MPH TRAVELING NORTHBOUND APPROACHING MY PATROL VEHICLE. I RECEIVED A CLEAR DOPPLER TONE WITH A READOUT OF 53 MPH. THE SPEED LIMIT ON THIS HIGHWAY IS 40MPH.

### OBSERVATION OF DRIVER:

DRIVER COULD NOT COMPLETE THE DIVIDED ATTENTION TASKS WHEN I REQUESTED LICENSE, REGISTRATION AND INSURANCE. LEONE ONLY PROVIDED HIS LICENSE ON THE FIRST ATTEMPT. ON THE SECOND ATTEMPT, LEONE THEN ONLY PROVIDED HIS REGISTRATION. ON THE THIRD ATTEMPT AFTER REQUESTING THE DOCUMENTS AGAIN, LEONE THEN PROVIDED HIS INSURANCE CARD. LEONE HAD BLOODSHOT RED EYES, WITH HEAVY RED MARKS UNDER THEM. LEONE SPEECH WAS SLURRED AND SAID IN A CONFUSING TONE WHEN HE STATED WHERE HE WAS COMING FROM.

### DRIVER'S STATEMENTS:

LEONE STATED HE WAS ON PROBATION AND THAT HE HAD THREE IPA'S AT A RESIDENCE ON FERN. HE SAID HE UNDERSTANDS HE MESSED UP BUT HE WANTED TO MAKE MENTION THAT HE WANTED A BREAK WITH THE CHARGES. LEONE REFUSED THE SFST'S ON SCENE. LEONE STATED HE WAS ON PRESCRIPTION MEDICINE FOR ACNE AND ECZEMA.





