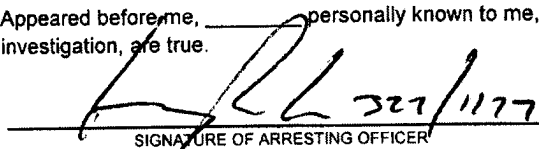
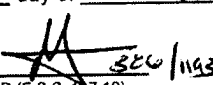

UPON ARRIVAL, OFC HOBBY ID386 REQUESTED THAT I ADMINISTER FIELD SOBRIETY TASKS ON KARA A CARTER (W/F 10/08/1991). OFC HOBBY TOLD ME THAT CARTER HAD A STRONG ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE COMING FROM HER PERSON, AND SHE DROVE TO THE PD AND WAS GOING TO DRIVE AWAY. CARTER WAS YELLING AND BEING UNCOOPERATIVE AS I TRIED TO REQUEST HER TO PERFORM THE TASKS. CARTER EVENTUALLY AGREED TO DO THEM BUT WOULD CONSTANTLY INTERRUPT AND WALK AWAY. I ATTEMPTED SEVERAL TIMES TO GIVE HER INSTRUCTIONS AND GET THROUGH THE FIRST TASK. CARTER CONTINUED TO BE BELLIGERENT, UNCOOPERATIVE AND DISORDERLY IN PUBLIC SO AT THIS TIME I PLACED HER IN HANDCUFFS. CARTER WAS NOT UNDER ARREST AT THIS TIME, BUT SHE WAS NOT FREE TO GO DUE TO MY INVESTIGATION OF A POSSIBLE BATTERY IN THE LOBBY WAS STILL ONGOING. DUE TO CARTER'S BEHAVIOR I FELT IT NECESSARY TO DETAIN HER UNTIL I COMPLETED MY INVESTIGATION.

I SPOKE WITH OFC LOPEZ WHO STATED THAT AMANDA SHEHATA WITH NORTHCOM ADVISED THAT SHE OBSERVED ON VIDEO CARTER GRAB MATTHEW W KITCHENS (W/M 03/02/1985) BY THE FACE AND JUST BELOW HIS NECK. SHEHATA STATED THAT KITCHENS STAYED SEATED AND DID NOT TOUCH CARTER.

I THEN SPOKE WITH KITCHENS WHO STATED THE FOLLOWING. KITCHENS TOLD THAT THEY WERE AT THE JUPITER PD LOBBY FOR A CHILD EXCHANGE. KITCHENS TURNED OVER THEIR SON IN COMMON, CHRISTIAN C KITCHENS (W/M 09/22/2016), TO CARTER. KITCHENS TOLD ME THAT HE SAW THAT CARTER WAS ACCOMPANIED BY ANOTHER PERSON WHICH HE EXPLAINED WAS NOT ALLOWED PER THERE CUSTODY AGREEMENT. KITCHENS SAID THAT HE TRIED TO USE THE PHONE IN THE LOBBY TO REQUEST THAT IT BE DOCUMENTED THAT CARTER BROUGHT ANOTHER PERSON TO THE CHILD EXCHANGE. KITCHENS SAID THAT CARTER HUNG UP THE PHONE BEFORE HE COULD FINISH SPEAKING WITH DISPATCH. KITCHENS TOLD ME THAT HE EXPLAINED TO CARTER THAT SHE COULD LEAVE BUT SHE REFUSED. KITCHENS STATED THAT HE SAT DOWN AND CARTER PUT HER HANDS ON HIS FACE. KITCHENS TOLD ME THAT HE TOLD HER TO GET HER HANDS OFF OF HIM A FEW TIMES BEFORE SHE DID.

STATEMENTS MADE TO ME BY KITCHENS ARE CONSISTENT WITH WHAT DISPATCHER SHEHATA OBSERVED ON VIDEO. BASED ON MY INVESTIGATION I BELIEVE KARA CARTER DID ACTUALLY AND INTENTIONALLY TOUCHED MATTHEW KITCHENS AGAINST HIS WILL WHILE IN THE JUPITER PD LOBBY, CONTRARY TO FLORIDA STATUTE 784.03. CARTER WAS PLACED UNDER ARREST AND TRANSPORTED TO JUPITER PD HOLDING FOR PROCESSING, AND THEN TRANSPORTED TO COUNTY JAIL WITHOUT INCIDENT.

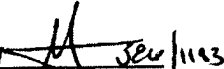
