

On October 17nd 2017, at approximately 0035 hours, I was parked in my marked PBSO patrol vehicle on the Northeast corner facing West on 7th Ave. South observing traffic on South Dixie Highway in the city of Lake Worth, FL. 33460. While parked I observed a gray 4 door sedan traveling South on Dixie Highway. I observed the vehicle to have it's headlights completely off. I then drove my marked PBSO patrol vehicle Southbound on Dixie Highway pulling directly behind the vehicle a gray Lincoln MKS bearing FL tag: DTS5E. I then initiated a traffic stop by activating my emergency overhead lights. Upon activating my lights the vehicle continued to travel South on Dixie Highway for approximately three blocks before finally pulling over on 15th Ave. South.

I made contact with the driver, Karen Brown Conrad (defendant), and requested her license and vehicle paper work. The defendant retrieved her black wallet from her purse and began to flip through her cards and passed her license twice before finally handing it to me. The defendant handed the vehicle registration and insurance card. I advised the defendant the reason for the traffic stop and she had no idea she was traveling without her headlights on. I explained to the defendant how to turn the headlights on, she then turned the headlight dial numerous times and still could not function the lights properly. While I was speaking with the defendant I could smell a strong odor of unknown alcoholic beverage emitting from her person and her eyes to be glasses with slightly slurred speech. The defendant stated, she was out with the "girls" prior to my interaction with her.

Deputy Reyka #17180 arrived on scene. Upon her arrival, I advised Deputy Reyka of my observations and turned the investigation over to her. Upon completing her investigation I returned to the vehicle to retrieve the defendants cell phone. I opened the drivers side door and found three single serving sized bottles of wine it should be noted two bottles were empty and the third was still half full and no cap on the bottle.

Karen received a traffic citation for her failure to drive with headlights during night.

This report is for supplemental purposes. This concludes my involvement in this incident.

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I responded as a backup unit to a traffic stop conducted by D/S Lowmaster #16028. When I arrived on scene, D/S Lowmaster advised me that he could smell alcohol on the driver. I approached the driver side window, and made contact with a female sitting in the driver seat, identified by Florida driver's license as Karen Conrad. Karen was not facing my way initially but was digging around in her center console. I immediately smelled a strong odor of alcohol emanating from the interior of the vehicle. I began speaking with Karen, and the odor grew stronger. I asked Karen where she was going, to which she began slurring something about going to feed her rescue dogs. I asked her where she was coming from, to which she stated "home". I asked her where home was, and she again began to incoherently mumble an address while pointing in the northerly direction.

OBSERVATION OF DRIVER:

Karen's eyes were bloodshot and her skin appeared very sweaty, despite her air conditioning being on full blast inside of the vehicle. I asked Karen to place the vehicle in park, turn the ignition off, and step out of the vehicle. She complied, and I asked her to walk to the front of the vehicle. I asked Karen once more where she was going. She again repeated that she was going to see her rescue dogs at a residence on 15th Ave. S. I asked her where she had come from, to which she very quietly mumbled "Sneakers", a well known bar in the City of Lake Worth. While speaking with Karen, I noticed she had a hard time staying focused on the questions I was asking, as well as could not stand still in one place but would rather sway back and forth slightly while speaking to me.

DRIVER'S STATEMENTS:

I asked Karen if she had consumed any alcohol tonight, to which she replied "yes, some" while shrugging her hands up in the air as if to signify the amount was not substantial enough to concern me. I asked her how much some was, to which she replied "I mean, I'm on a new diet, so I'm trying to not drink a lot". I again asked her how much some was, to which she advised "one glass". I asked her what the one glass was of, to which she advised she had drank one glass of red wine. She then informed me that she had not consumed any alcohol while at Sneakers, but had only ordered a bottle of water while there. I asked her where she had drank, and she stated the wine was drank at her residence prior to going to Sneakers. I further explained to Karen that I was concerned that the alcohol had impaired her normal faculties, and I asked if she would consent to roadside sobriety tasks to determine her impairment levels. Karen began to panic, asking me if I would be able to give her a break because she is a Nurse. I explained to her again the purpose of the roadsides, to which she consented to performing but again was insistent about not wanting to get in trouble.

ODORS:

A strong odor of alcohol emanated from within the vehicle as well as from Karen's person and mouth as I made contact with her and engaged in further conversation.

GENERAL OBSERVATIONS

SPEECH: Very slurred and quiet

ATTITUDE: Cooperative but extremely worrisome

CLOTHING: Blue cardigan, black tank top, jean capris, black sandals

MEDICAL/OTHER: Initially advised of nothing on scene; provided a list of thyroid and sleep medications to BAT Technician upon arrival at facility

Other Observations:

Karen struggled to stay focused and would slur comments that I could not understand while performing the roadside tasks. After being advised repeatedly to maintain the instructional stance for each task, Karen would continue to try to perform the task as I explained it and when asked to stop and wait, her response was "I'm just practicing".

WALK & TURN:

Karen struggled to follow along with me as I provided instructions for the task. I asked her to keep her feet together and hands at her side while I explained the task to her, and she failed to maintain such stance. I asked her to watch me demonstrate the task before she did, to which she would get distracted from losing her own balance and would have to be redirected on task. Karen failed to maintain heel-to-toe on any of her steps. She also failed to keep her feet on the ground as instructed when turning around. Karen did not count out loud until she reached step 9 on the initial walk and then the walk back.

ONE LEG STAND:

Karen failed to keep her leg straight while completing the task. She began counting at a normal pace but would then speed up through a few numbers, slow back down to a normal pace, speed up again and repeat this until I finally stopped her.

FINGER TO NOSE:

Karen failed to return her hands to her side after each instruction to touch her finger to her nose. She would leave her finger on her nose until I asked her to put it back down at her side. One time she touched the bridge of her nose instead of the tip of her nose. She would waver her finger over her nose for a brief second each time as if to make sure the tip of her finger was in fact going to make contact with the tip of her nose.

ROMBERG ALPHABET:

Karen was instructed to recite the alphabet in a non-rhythmical pattern, but did not follow instructions and did the opposite.




