Once again the vehicle sped up and diverted into the parking lot of the Mobile Gas Station on 15th Ave North and Dixie Hwy. Once there I observed the defendant (later identified as Karen Merlene Doolittle) watching for my patrol vehicle to pass so she could continue North on Dixie. At this point I initiated a traffic stop on Doolittle's vehicle. I placed my Patrol car on Dixie Hwy and gave instructions via loudspeakers. Doolittle looked around to see if she had an avenue for escape, and I ordered her to place the vehicle in park. Doolittle began yelling out her window, and continued to try and move her her vehicle onto Dixie Hwy. I then ordered her to take the keys out of the ignition, to which she complied.

Upon speaking with Doolittle, she stated she was delivering pizzas. Doolittle was noted to be irate and would not give direct answers to questions asked. Doolittle also stated she lived in Sebastian, FL where she worked at a pizza parlor. Doolittle claimed she was delivering pizza's to the city of Lake Worth from Sebastian. It should be noted Sebastian is approximately 100 miles north of Lake Worth. Doolittle was noted to have a strong odor of unknown alcohol beverage on or about her, and seemed to be slightly confused. When asked if she had anything to drink tonight, Doolittle smiled and stated she had been drinking.

## PERSONAL CONTACT

### DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On Saturday December 09, 2017 at approximately 22:54 hours, I responded to 1411 N Dixie Hwy in the City of Lake Worth Florida, 33460 to a traffic stop involving a possible impaired motorist. Upon my arrival, I met with Deputy Enos #24750 who told me the following, "Upon routine patrol on the 1000 block of South Dixie Hwy in Lake Worth, FL 33460, I observed a gray Dodge Minivan (bearing Indiana tag 186PAC) driving erratically in the north bound lane. I proceeded to follow the vehicle and noticed the vehicle picking up speed. I observed the vehicle swerving and almost hit the curb several times between 6th Ave South and 1st Ave South. The vehicle then proceeded north past Lucerne Ave where it changed lanes multiple times to avoid colliding with other vehicles on the road. I observed the vehicle crossing over the yellow lane markers multiple times as it sped north. ### OBSERVATION OF DRIVER:

I observed the driver who verbally identified herself as Karen Merlene Doolittle was wearing blue jean pants and black shirt. While questioning Doolittle she seemed upset and agitated when I asked her if she had been made aware of why she had been stopped. I observed Doolittle's eyes appeared red and glassy. I observed that she did not respond right away and had a delay when answering. Doolittle was asked to exit the vehicle to perform field sobriety tasks to make sure she was O.K. to drive. Doolittle agreed and exited her vehicle.

### DRIVER'S STATEMENTS:

I asked Doolittle if she had been drinking or used any drugs. Doolittle stated she drank a beer earlier approximately two hours prior to being stopped and could not recall what kind of beer she drank. I asked Doolittle if she had any medical problems and/or previous injuries? Doolittle stated she had arthritis and takes several medications which consisted of Lexapro, 2 inhalers, anti acid, methoprolone, and levothyroxine. I noticed Doolittle was wearing glasses which she removed prior to conducting SFST's. I asked Doolittle if she wore contacts and she said no.

### ODORS:

Obvious odor of unknown alcoholic beverage.



**ROADSIDE TASKS**

**HORIZONTAL GAZE NYSTAGMUS:**

- LT EYE-LACK OF SMOOTH PURSUIT
- RT EYE-LACK OF SMOOTH PURSUIT
- LT EYE-DISTINCT & SUSTAINED NYSTAGMUS AT MAX. DEVIATION
- RT EYE-DISTINCT & SUSTAINED NYSTAGMUS AT MAX. DEVIATION
- LT- EYE-ONSET OF NYSTAGMUS PRIOR TO 45 DEGREES
- RT- EYE-ONSET OF NYSTAGMUS PRIOR TO 45 DEGREES

**Other Observations:**

Once positioned in the front of my vehicle, I continued my investigation. I instructed Doolittle to keep her hands by her side, stand with her feet together, and follow a red light stimulus with her eyes not turning her head. I asked her if she understood my instructions. Doolittle verbally stated she understood my instructions. Doolittle swayed back and forth while standing stationary. I observed both eyes to be red, bloodshot, and glossy. Her left and right eye displayed equal pupil size, equal tracking, and a lack of smooth pursuit. I observed distinct and sustained nystagmus was present in both her left and right eye at maximum deviation during two separate four second evaluations. The onset of nystagmus was prior to a 45 degree angle in both her left and right eye during two separate four second evaluations. While conducting the task I had to remind her to keep hands by her side, not turn her head and follow the stimulus multiple times.

**WALK & TURN:**

I positioned Doolittle on a white line created utilizing duct tape which was on a smooth and level surface, free of any debris and well lit by the headlights on my vehicle and (nearby street lighting). I instructed the driver to place her left foot on the line and her right foot in front of the left touching heel to toe. I instructed her that she was to keep her hands at her side and stay in this position until I instructed her to do otherwise. I instructed her to walk nine heel to toe steps counting out loud, while watching her feet. On the ninth step he/she was to keep his/her front foot on the line and use his/her back foot, in a series of small steps, to turn around before walking nine heel to toe steps the opposite direction counting out loud and watching her feet. I demonstrated the task while I was verbally instructing her in the proper way to complete the task. During the instructional phase, Doolittle started too soon and had to be told to return to the instructed position. Doolittle became agitated and upon me completing instructions she began once again before I could ask if she understood my instructions. I observed Doolittle swayed back and forth while balancing, started too soon, stops walking to steady self, did not touch heel to toe, stepped off the line and counted ten steps without utilizing the line. I asked Doolittle to return to the start of the tape and resume the instructed position. I attempted to ask Doolittle if she understood my instructions and she once again started the task without being told to do so. I observed Doolittle utilized her arms for balance did not turn properly and did not complete second series of heel to toe steps. Doolittle returned to the start of the tape and proceeded to do the same exact thing two more times before I concluded task and moved on to the one leg stance.

**ONE LEG STAND:**

I told Doolittle we were going to proceed to another task at which time I asked her to place her feet together and arms at her side. I demonstrated the task as I verbally instructed her to raise one of her feet approximately six inches off of the ground, point her toe towards my patrol car, look at her raised foot, and count out loud 1001, 1002, 1003 and so on until told to stop. I asked her if she understood the instructions and demonstration I provided. After Doolittle stated she understood my instructions, the task was performed. While raising her foot she swayed while balancing, used her arms for balance by placing them into the pockets of her jacket. Doolittle was told to take her hands out of her pockets and to place both arms to her side, down by her legs. Doolittle dropped her foot 3 times within within 30 seconds.

**FINGER TO NOSE:**

I instructed Doolittle to stand with her feet together, make each hand into a fist keeping, extended her index fingers and to place her palms facing up. She was instructed to lower her arms by her side. I instructed and demonstrated the proper hand and arm position and for her to remain in this position while I demonstrated the rest of the task. I instructed and demonstrated her to tilt her head back approximately 45 degrees and close her eyes while waiting for a verbal command of left or right. On the command of "left" or "right", she would raise the requested hand, touch the tip of her finger to the tip of her nose, then bring her hand immediately back down to her side. I asked her if she understood the instructions I provided and she verbally stated she understood. I instructed her to start the task as explained. During the task, I observed Doolittle did not keep eyes closed, failed to return arms to side, correct finger did not touch tip of nose twice, used wrong hand twice.

**ROMBERG ALPHABET:**

I verbally inquired if Doolittle could recite the entire English alphabet. She stated she was able to recite the English alphabet and I instructed her to place her feet together with her arms at her side and stay in this position until told to do otherwise. I instructed her that upon starting sge was to tilt ger head back approximately 45 degrees and close their eyes. She would begin to state the alphabet in a slow and methodical manner without singing or rhyming it. I asked her if she understood the instructions and she verbally replied she understood. During the instructions she continued to sway while standing stationary. I instructed Doolittle to start the task as explained. During the task, I observed Doolittle did not keep eyes closed, from front to back, used arms for balancing (more than 6').
