On the 15 day of December, 2016 at 14:15 (Specifically include facts constituting cause for arrest.)

On 12/14/2016 at approximately 0900 hours, I was dispatched to 2300 Via Royale unit 2305 in reference to a suspicious incident. Upon arrival, I made contact with [REDACTED] who told me the following information:

[REDACTED] advised he was out of town for the last five days and returned to his apartment to find the locks changed (See JPD report 16-005972). He said he has been living in the apartment for approximately 3 or 4 months, is the only person on the lease and that no one else has lived in or had a key to his apartment. He said he has been having problems with his ex girlfriend, Karen Ingram, who he lived with prior to living at his current apartment. He told me he and Ingram broke up approximately five months ago. He said she should not know where he lives, however, she did tell him she hired a private investigator to follow him.

[REDACTED] said in the last five months, Ingram has called and sent him several text messages a day from number 561 972 0728, a number he knows to belong to Ingram and has used to contact her in the past. He said the text messages are erratic and emotional. He said they range from apologetic to irate and are unpredictable. [REDACTED] said he told Ingram he did not want to talk to her anymore but she continued to contact him. He told me the text messages and phone calls were so excessive that they effected his daily life and he eventually blocked her phone number toward the end of September, 2016. [REDACTED] advised he began receiving calls from number that he did not recognize. He said when he answered, she would begin speaking and he would hang up and immediately block the number. He said once he blocked the number, she would call back using a different number. He told me he received several calls a day from Ingram on multiple numbers.

[REDACTED] also advised Ingram uses multiple email addresses to send him emails. He said he flagged the emails as Spam so that they get sent to a "spam" folder. He showed me the folder, which contained several emails from Ingram from November 14, 2016 through

December 14, 2016. The folder said on the top that the messages are automatically deleted after 30 days. The email address karenagoforth@gmail.com is the address Ingram most often used and is an address [REDACTED] said he knows to belong to Ingram and has used to contact her in the past. The emails all say "Sent from my iPhone" at the bottom, indicating they are originating from a cellular device. Ingram also used her cellphone number (561 972 0728) and annebaker85@gmail.com, which is named "Karen Baker" and also originated from an iPhone.

[REDACTED] said he has taken every measure possible to block Ingram from his cell phone and social media sites, yet she has continued to contact him several times a day after he has repeatedly asked her to stop. He advised Ingram still calls and texts him from multiple numbers daily and sends him several emails a day from various email addresses.

[REDACTED] said he is afraid of Ingram and wishes to pursue a restraining order against her. He said the harassment and stalking has caused him to feel the need to alter his lifestyle to avoid Ingram. He said he is afraid to leave his apartment because he believes she will break in and damage or steal his belongings. [REDACTED] said he no longer feels safe now that she knows where he lives.

[REDACTED] came to the Jupiter Police Department on 12/14/2016 and met with Agent Harrington. Agent Harrington downloaded the call log and text messages from [REDACTED]'s LG cellphone [REDACTED]. Agent Harrington advised he was unable to download the emails from the Spam folder. [REDACTED] forwarded several emails to my work email address that were sent to his email address [REDACTED], which I later printed out and placed into JPD evidence. The CD provided to me by Agent Harrington was also placed into JPD evidence.

The emails were excessive in frequency and seemed to serve no legitimate purpose other than to manipulate [REDACTED] into meeting and conversing with her after he has told her he does not wish to do so. The emails and text messages often ask for money or items Ingram says she is owed, express wanting to speak to [REDACTED]'s mother, or asking to reconcile and "be friends". The emails were sent over a period of time from September, 2016 to today. [REDACTED] advised he has not responded to any form of communication for months.

[REDACTED] advised he is willing to prosecute Ingram for cyberstalking/harassing phone calls. He completed and signed a sworn witness statement and was issued a victims rights brochure.

I made contact with Ingram at her apartment. I began speaking to Ingram reference the items she believes were stolen from her. During our conversation, Ingram told me she called a locksmith to change the locks on her mailbox at her previous residence, but she could not remember who she called. Ingram also made statements about knowing that

She told me she sends him an email "probably every day". She said she used to call and text him but said he "probably" blocked her phone number about two months ago. She told me she sends him emails about the belongings she thinks he owes her, and sometimes "gets angry" and "says mean things". She said she usually emails back to apologize for the "mean things". She said [REDACTED] told her several months ago to stop contacting her. She told me [REDACTED] told her if she continued to contact him, he would pursue harassing charges against her. Ingram said she continues to contact him but that he has not responded for several months.
