




While making this last turn, the vehicle ran over and knocked down a stop sign left the scene and, continued towards 3025 S Federal Hwy where it came to a stop. They kept watch on the vehicle and observed a white male, later identified as Karen Sargsyan, wearing a black shirt exit the vehicle from the driver's side door with what appeared to be a cup in his hands. Both Iliff and Ozarowski waited and watched Karen until law enforcement arrival. Both Iliff and Ozarowski provided officers with sworn witness written statements of this account.</p> <p>Upon my arrival, I made contact with Ofc. Florvil who provided me with Karen's FL/DL and contact information. He also provided me with Karen's cousin - Arthur Sargsyan, contact information as he was the owner of the vehicle. noticed that his speech was very slurred and he had very slow comprehension.

I then made contact with Ofc. Mitchell who was in contact with witnesses Iliff and Ozarowski. I spoke with both Iliff and Ozarowski and asked them if they were willing to participate in a show-up to better identify Karen as the driver of the vehicle they had seen swerving and leaving the scene of a crash. They both stated yes and due to the fact that Iliff was underage, I asked her mother, Brooke for permission as well, and she said yes. I then walked over with Iliff and Ozarowski to the general location of where Karen and Arthur were. I pulled Iliff away from Ozarowski and asked her if she recognized anybody on scene as the driver of the vehicle. Iliff pointed to Karen and stated that he was driving. I then did the same with Ozarowski and he stated that he did not get a good look at the driver when he was inside of the vehicle. I relieved Iliff and Ozarowski from the scene and they left without incident. It should be noted that during this interaction, I was notified by Ofc. Florvil that Karen had thrown up and had to sit down.


I then asked Karen to stand up and walk towards the view of my In Car Camera of marked patrol unit #1304. Karen could not stand up or walk on his own at this point and needed assistance from Arthur to do so. After walking Karen to the spot I had asked, Arthur let go of his arm and Karen was still stumbling and swaying to the point of almost falling down. I introduced myself and Ofc. Mitchell, read Karen his Miranda Warnings and asked him if he understood to which he replied yes. I then let Ofc. Mitchell conduct his crash investigation and once done, I took over the scene. I explained to Karen the reason as to my presence on scene (DUI investigation) and requested for him to submit to the Standardized Field Sobriety Testing Tasks and he said yes.

I conducted the tasks while Arthur translated for Karen to ensure that he did understand the instructions. Based on my investigation, I determined that there was Probable Cause for Karen Sargsyan's arrest. Karen was arrested with his hands behind his back and the handcuffs were double locked and checked for proper spacing. Karen was transported to PBCJ BAT. While on the way to PBCJ BAT, Karen threw up once again but this time, on himself and the rear of my patrol vehicle. It should be noted that all interactions up to this point between Karen, Arthur, Iliff, Ozarowski and myself, were captured on my In Car Camera of marked patrol vehicle #1304 and my Body Worn Camera.

At the PBCJ BAT, Karen was very confrontational and belligerent. After the 20-minute observation period, Karen agreed to submit to a testing of his breath. After the testing was done, he refused to answer any questions. Once inside the holding cell at the BAT, Karen became very irate, confrontational, and belligerent. Karen started screaming, yelling, and endlessly banging on the cell door with his head, hands and feet. I handcuffed Karen again behind his back, the handcuffs were double locked and checked for proper spacing, in an attempt to deter Karen from continuing his behavior and/or possibly hurt himself. Karen continued kicking and banging the door with his feet and

**LEFT EYE:** Does not follow smoothly, jerks at 45 degree angle or less, showed distinct jerking at maximum deviation.

**RIGHT EYE:** Does not follow smoothly, jerks at 45 degree angle or less, showed distinct jerking at maximum deviation.

**WALK AND TURN:** While listening to the instructions, Karen could not keep his balance, kept swaying and could not stay at the position he was initially asked to stay at due to complete lack of balance. I asked Arthur (cousin) to repeat each instruction as I demonstrated to Karen twice. Karen was unable to perform the task.

**ONE LEG STAND:** While attempting to perform the task and throughout the duration of the task, Karen kept swaying and hopping in an attempt to keep his balance. Once again, Arthur translated each instruction and Karen stated that he understood. While performing the task Arthur can be seen and heard on video reminding Karen of the instructions and Karen is seen attempting to correct himself. Karen could not start the task until after approximately 10 seconds after I had instructed him to start and he put his foot down 3 times before the 30 seconds had elapsed.

**FINGER TO NOSE:** Once again, Arthur translated each instruction and Karen stated that he understood. While performing the task Arthur can be seen and heard on video reminding

Karen of the instructions and Karen is seen attempting to correct himself. Throughout the task, Karen did not close his eyes or tilt his head back unless reminded by Arthur. Karen failed to return his arm down to hi side on the first two commands and on the first command he raised his hand and stretched his arm out in front of him without touching his nose. On the 3rd command of RIGHT, he used his left hand and, on the 2nd command of left, the middle of his index finger touched the bridge of his nose.

RHOMBERG ALPHABET: While performing this task, Karen kept swaying and did not recite the alphabet to its entirety even after being reminded by Arthur. Karen incorrectly recited the alphabet and towards the end of his performance, he started mumbling unrecognizable words.
