<p>On the 3RD day of AUGUST 20 17 at 0351hrs <input type="checkbox"/> A.M. <input type="checkbox"/> P.M. (Specifically include facts constituting cause for arrest.)</p> <p>On Thursday, August 3, 2017 at approximately 0330hrs, I D/S A. D'Orsi ID: 24983 was on duty driving an unmarked PBSO vehicle past 703 Sunny Pine Way Greenacres, FL. It was at this time I observed a silver Ford 4 door bearing FL tag K455CM parked in space 137. I noticed a black male in the driver's seat, another black male and a white female standing outside of the vehicle leaning in holding a purse and a large white and blue foam cup. I was immediately suspicious of these people due to the fact I am very familiar with all of the residents of this building, I have never seen them before and that there has been multiple narcotics related cases stemming from the residents of 703 Sunny Pine Way F1 to include multiple narcotics overdoses even including an overdose death recently. I exited my vehicle wearing a PBSO BDU Uniform and approached the vehicle. I noticed that the female tossed a round shaped object into the grass in front of the vehicle and also heard the sound of metal hitting the pavement. It was then I requested a backup unit so I could conduct an official investigation. B/M Joseph R. Mezzidor DOB: 02/06/1974 whom was out of the vehicle advised me he had a crack pipe and a small amount of marijuana on his person prior to me patting him down for weapons. He was placed in handcuffs at that time. Next I had B/M Clifford Blaise DOB: 08/06/1976 exit the driver's seat of the vehicle. I noticed the object the female threw in front of the vehicle near the grass. I observed a glass crack pipe connected to an approximate 1.5 foot piece of plastic pvc tubing. This is a common way crack smokers avoid burning their lips and fingers. Blaise was placed in handcuffs at that time due to the fact the investigation was escalating. I asked the female to identify herself. She claimed she did not have an ID and provided the name Kaye Stevens DOB: 01/13/1974. I records check of this name came back to no such person. She insisted that was her name and provided it again. I advised her I saw her throw the crack pipe and she was going to be placed under arrest for that and further asked if the reason she was providing me a false name because she had a warrant for her arrest. She said maybe. It was at that time she was placed in handcuffs. She later provided the name of Kari Roberts DOB: 01/31/1975. She was then identified properly and did in fact have a warrant for her arrest ref warrant number PBSO 17002769. A search was conducted of her property. It was at that time I found a white Krazy Glue container inside of the blue and white foam cup she was holding. (note: the cup contained no liquid) The Krazy Glue Container had 0.7 grams of crack cocaine inside of it. Next in plain view, I noticed a clear capsule containing tan heroin in it. The capsule looked like it had been crushed however it was still in tact directly on the floorboard next to the driver's seat of the vehicle that was in Blaise's immediate control when I encountered him. I recovered the crack pipe with the tube attached that was in the grass about 6 inches from the pavement. Directly in front of it on the pavement was an approximately 8 inch long metal rod (pushrod) used for cleaning the crackpipe out. When that hit the ground after Roberts threw it was the sound I heard and described above.</p> <p>Based on the facts as described above B/M Clifford Blaise was arrested for possession of heroin 0.3 grams B/M Joseph Mezzidor was arrested for possession of marijuana less than 20 grams (1.4 grams) and possession of paraphernalia (crack pipe with residue). W/F Kari Roberts was arrested for possession of crack cocaine (0.7grams), possession of paraphernalia (crack pipe on tube and pushrod), tampering with evidence for throwing the crackpipe and pushrod, and obstruction by disguised person for providing and insisting the false name of Kaye Stevens DOB: 01/13/1974 multiple times.</p> <p>The cocaine tested positive with a Cobalt field test kit and negative with a Marquis. the Marijuana tested positive with a Duquenois field test kit. The heroin was not tested due the fact the capsule could not be taken apart in its condition and it a suspected to contain fentanyl.</p> <p>All three were transported to the PBSO D 16 sub station for processing. All mentioned narcotics were weighed using an Ohaus triple beam scale. All evidence was packaged and placed into evidence lockers at the PBSO D-16 evidence lockers.</p> <p>All three defendants were transported to the Palm Beach County Jail without further incident.</p>
