D.U.I. PROBABLE CAUSE AFFIDAVIT

ON THE 18 DAY OF JUNE 20 17, AT 0221 AM PM

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On Sunday, June 18, 2017 at approximately 0230 hours, I responded to Lake Worth Road and Jog Road, Green Acres (Palm Beach County) Florida to assist Deputy John Booth with a motorist who was passed out in the driver seat. While en route to this location Palm Beach Communications advised the female in the driver appeared to be breathing but was not moving. Upon my arrival I noticed several emergency vehicles stopped in the east bound lane of Lake Worth Road facing east. I saw a blue vehicle stopped in the #2 through lane facing east. All of the emergency vehicles had their emergency lights activated. I met with D/S Booth who told me the following regarding this incident: On 6/18/17 at 02:21 Hours I D/S Booth #24998 responded to the intersection of Lake Worth Rd and S Jog Rd in reference to a medical call. While in route PBSO dispatch advised that they received a call stated that there was unresponsive female "Passed" out behind the wheel.

Upon arrival I observed a blue Chevy Cruz Bearing tag 301QRL facing eastbound on Lake Worth Rd. The vehicle was stopped approximately 30 feet from the stop bar at the intersection for Jog Rd. Upon arrival I observed a W/F later identified as Karissa Rice DOB 2/22/95. Rice was sitting in the drivers seat of the vehicle with her head tilted back against the head rest. Rice appeared to be asleep and was not responsive. The vehicle at that time was still running, all the doors were locked and it was still in drive. I attempted to wake Rice up by knocking on the drivers side window but was unsuccessful.

A short time later Greenacres Fire Rescue responded and used a window punch to open the passenger side front window to gain access into the vehicle. Once the window was broken the vehicle was turned off and the keys were removed from the vehicle. The doors were unlocked and Rice and finally became awake. When I asked Rice if she was okay she said she and she was going home. A short time later D.U.I investigator arrived on scene and the investigation was turned over to him: D/S Booth wrote a statement on a probable cause affidavit.

OBSERVATION OF DRIVER:

I made contact with the driver who was sitting in the driver seat of a blue vehicle. She was later identified as Karissa Marie Rice by her Florida driver license. She seemed disoriented and unaware of her surroundings. I noticed the passenger side glass broken out. It landed inside the passenger seat. During my interview I noticed her eyes were red, watery and glossy. Her mouth was dry and frothy. I could smell an odor of an unknown alcoholic beverage emanating from the inside of the vehicle. I explained to the driver that her vehicle was stopped in the roadway obstructing traffic. Paramedics responded to assess her for any type of medical emergency she may have been experiencing. I told her they attempted to wake her but she would not respond. They ultimately had to break out her window to gain access to her. She told me she was having a bad night. She said she was leaving the airport and heading home. I explained I had a suspicion she had been drinking an unspecified amount of unknown alcoholic beverages. She later said she had one drink. Moreover I asked if he would consent to performing Standardized Field Sobriety Evaluations (SFSTs) for the purpose of determining if he was impaired while operating a motor vehicle. The defendant refused, so I gave the Taylor Warnings and explained the evidence that I already had against her (red and glossy eyes, vehicle stopped in the roadway obstructing traffic, the smell of an unknown alcoholic beverage coming from her breath) would be strong basis for her being arrested.) I asked if she would reconsider her refusal and perform tasks. She told me she did not want to perform the tasks. I asked her to exit her vehicle. She displayed some unsteadiness while standing. She began crying and was visibly upset. She asked to call her father and exclaimed that he (her father) was going to kill her. She also felt that was about her boyfriend. I could now smell a strong odor of an unknown alcoholic beverage coming from her breath which intensified when they spoke. Based on D/S Booth's observation of her being in actual physical control of her vehicle, to include the vehicle operational and running, her sitting in the driver seat of her vehicle while it was in drive and my observation of personal indicators of impairment exhibited by her, probable cause was established for DUL Sergeant T. Sanford responded to execute a search of the defendant's person. Afterward she secured her in handcuff that were double locked and checked for proper fit prior to seating her into the rear of my patrol car.




