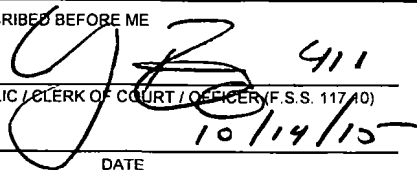
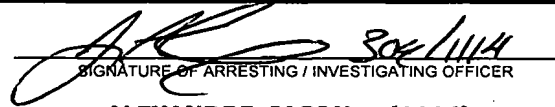

On the 14 day of October, 2015 at 12:57 (Specifically include facts constituting cause for arrest.) On 10/11/15, at approximately 1415 hours, I, Officer Alexandre, was dispatched to A1A S of Jupiter Reef Club for a report of a Criminal Mischief to a vehicle. Upon arrival, I met with the complainant, later identified as Catherine M. Vega DOB 10/14/61, who advised her vehicle was keyed while she was at the beach. Vega states she parked just south of the Reef Club at approximately 0930hrs. When she responded back to her vehicle, at approximately 1410hrs, she noticed a large amount of damage to the exterior of her vehicle. Her vehicle was keyed from the passenger's side door all the way around the back to the driver's side door. A large X was also keyed on the top of her trunk. Vega also noticed a large amount of nails placed in front of both her front tires. These nails did not cause any damage that Vega noticed, however, she did state that her tires have had nails placed into them in the past. Vega believes that the nails were an attempt to deflate her tires as she drove away. Vega stated that she has had issues with an ex-boyfriend, identified as Karl Schuman DOB 01/05/65, who has keyed her vehicle in the past. Vega has an open investigation with MCSO, and a closed investigation with this agency where Schuman is the suspect. Schuman is uncooperative at this time. Vega did state that she has set up a camera in her vehicle to video record Schuman committing these acts. Vega was unable to access this video during the time of this report. She believes her battery was drained, however, she advised me that she would notify me if she is able to obtain video surveillance of this incident. Vega estimates the damage done to her vehicle to be approximately \$2,000. This case is pending further evidence and follow up investigation. On 10/14/2015 I conducted a follow up investigation into this case. Vega did provide

video surveillance from her vehicle on 10/11/2015. The video displays that around 1315 hours, a white male with a camouflage shirt walks around her vehicle and looks inside. The white male squats down by both front tires where the nails were placed. The white male continues to walk around Vegas vehicle extending his right arm towards her vehicle in a manner consistent with a person intentionally scratching the side of the vehicle with an object in his hand. The male exits the scope of the video at approximately 1316 hours. Vega reviewed the video, and stated to Officer Zorro that she positively identifies the white male in the video as her ex-boyfriend Karl Schuman DOB 01/05/65. Vega completed a Jupiter Police Department witness statement documenting that she is certain that the subject in the video is Schuman. I reviewed all of Vega's statements as well as copies of the still photographs and video surveillance. The subject in the video matches the description given to me of the suspect Karl Schuman. All attempts to contact Schuman have been unsuccessful. Vega has recently received a No Contact Order for Schuman who has been harassing her. She has provided a text message from Schuman that states "Good luck getting those scratches out." This text was in reference to JPD case #15-002666. In this case Vega reported that her car was keyed causing approximately \$1000.00 worth of damage. Based on the above facts and circumstances I am requesting a warrant be issued for Karl Schuman for willfully and maliciously damaging or injuring by any means any real or personal property belonging to another, Criminal Mischief over \$1000 F.S.S. 806.13(1)B(3). Still images were captured and enhanced from this video by the JPD Criminal Investigations Unit. These images have been saved and submitted into evidence on CD. I have spoken to Vega and updated her on the status of this case.
