

The traffic light was green for Northbound and Southbound traffic. The Infinity entered the intersection at a slow speed. The vehicle then stopped in the middle of the intersection. Vehicles traveling from all directions stopped in order to avoid striking said vehicle. I then activated my emergency lights on my fully marked patrol vehicle and pull in-front of said vehicle . I then observed a white female later identified by DAVID as Kasey Osis (05/06/1987) unconscious behind the wheel, she was in full control of said vehicle with her seatbelt on. Osis's eyes were closed and would not wake up. I then active my siren multiple times with negative result to wake her. Osis' vehicle continued to move forward passed southbound lanes. I parked my patrol vehicle in front of her and got out to check on Osis. I then knocked on her windows to wake her up. Osis opened her eyes and appeared confused as to where she was. I then told her to park her vehicle. Upon speaking to Osis I observed her eyes were pin point and her speech was very slurred. Osis stepped out and was not able to balance on her feet. Osis eyes continued to close as she was falling asleep.</p> <p>I then advised Osis that I was starting my DUI investigation and if she was willing to conducted some road side tasks. Osis agreed to take my road side tasks.</p> <p>I then moved her vehicle out of the roadway and conducted my investigation in the Burger King parking lot located at 1001 S Dixie Hwy. I then conducted my field sobriety tasks at said location (see roadside tasks for further information). Officer M. Blanco used his vehicle to record the roadside tasks with his dask camera.</p>
