The Toyota continued southbound when I initiated a traffic stop. We made our final stop at approximately 2200 NW Renaissance Way.</p> <p>I approached the vehicle and observed a B/M, identified as James Alabre, in the driver seat and a W/F, Kassandra Gonzales, in the passenger seat. I immediately smelled the odor of marijuana emanating from the interior of the vehicle. Sergeant Dubinsky and Officer Alvarez arrived on scene as my back-up officers.</p> <p>I asked both Alabre and Gonzales to exit the vehicle separately. When Gonzales exited the vehicle, she stated that she wanted to tell me something. I then spoke to Gonzales separately away from everyone else. Gonzales stated that her purse that was in the passenger seat contained a baggie of cocaine. It should be noted that I did not ask Gonzales any questions and she spoke to me on her own accord.</p> <p>I searched the interior of the vehicle and discovered a white powdery substance inside of a clear plastic baggie in the purse that Gonzales informed me about. I also discovered a rolled up dollar bill inside of the purse next to the white powdery substance.</p> <p>Sergeant Dubinsky read Gonzales her Constitutional Warnings. I read Alabre his Constitutional Warnings from a pre-printed, department issued Miranda Card. Both of them stated they understood their rights and wished to speak to me. Alabre stated that he was not aware of the cocaine in Gonzales' purse and that there were no other narcotics in the vehicle.</p> <p>I then spoke to Gonzales who confirmed that the white powdery substance was cocaine and</p>

it belonged to her. Gonzales stated that she used the rolled up dollar bill to snort the cocaine.

Due to Gonzales admitting that she had cocaine in her purse and the white powdery substance having the consistencies of cocaine, I charged Gonzales with possession of cocaine F.S.S 893.13(6A). Also, with Gonzales admitting that she used the rolled up dollar bill to snort the cocaine I charged her with possession of paraphernalia pursuant F.S.S. 893.147. I transported Gonzales to BRPD's temporary holding facility for processing then to the PBCJ.

While in booking, I tested the white powdery substance using a department issued Quick Check Test Kit (one use only). The test was positive by turning blue. The cocaine (2.1g) and the rolled up dollar bill were later submitted into BRPD evidence.
