On the 17 day of February, 2018 at 00:10 (Specifically include facts constituting cause for arrest.)

On 02/16/2018 at approximately 2309 hours, I was dispatched to a domestic disturbance at 1776 N Military Trail (McDonald's) in reference to a domestic disturbance.

Upon arrival, I met with Dean Lavelle who told me he and his fiancé, Katarina Webb, were leaving Strike's Bowling Alley and began to argue. Lavelle said Webb was mad at him because he beat her in billiards. He said he dropped Webb off in the Boca Center Plaza and went the McDonald's across the street to calm down. Lavelle parked on the east side of the McDonald's and brought his food back out to his vehicle. Lavelle said Webb got in the vehicle on the passenger side, threw her purse in the vehicle, and demanded fries. Lavelle said he offered to drive thru, but Webb refused and took the keys out of the ignition so he grabbed her purse and offered to trade. Webb refused and grabbed his arm leaving scratch marks. Lavelle told me he threw her purse out of the vehicle and she got out with his keys. She then set the vehicle alarm off from the key fob. Lavelle said he went inside the McDonald's to get away from the noise and Webb entered the vehicle and began to back the truck up. Lavelle said he ran out and hit the window telling her to stop. Webb stopped and opened the window and Lavelle leaned in and took the keys from the ignition. BRPD arrived shortly after. Lavelle completed a witness statement form.

I spoke with Webb who said she was dropped off by the Rocco's Tacos in the Boca Center Plaza during their argument and sat on a bench for a bit, while Lavelle went to McDonald's get some food for himself. Webb said she walked to McDonald's and entered Lavelle's vehicle where he was eating and took his car keys from the ignition. Webb said when Lavelle reached to take the keys from her hand, she grabbed his arm.

There were no witnesses to the incident. Photos of Lavelle's injuries were taken and submitted into BRPD evidence. Based on my investigation Webb is being charged with F.S.S. 784.03(1A1) Simple Battery, Domestic. Webb was transported to County Jail.
