<p>This incident occurred in the city of Delray Beach, Palm Beach County FL.</p> <p>On 10/23/16 at 1:25 PM I was dispatched to 235 Via D'Este #1601 in reference to a domestic disturbance. Upon arrival, I observed a W/F, later identified by FL DL as Kate Lohan, who appeared to be intoxicated standing in front of this location yelling and causing a disturbance. Kate was upset and angry at her husband, Michael Lohan for an unknown reason.</p> <p>When I asked Michael about this incident, Michael stated that Kate went over to their neighbor's house earlier in the night. Michael stated that Kate came into his residence heavily intoxicated. Michael and Kate do not live together and due to Kate's heavy intoxication, he told Kate she could not stay at his house tonight and that she needed to leave. Michael stated that Kate became angry and started yelling at Michael. Michael stated that he then called his neighbor, Gregory Fino, to come over and help remove Kate from the house and find her a ride home.</p> <p>While talking to Michael inside his residence, Ofc. Leblanc was outside talking Kate. Ofc. Leblanc stated that Kate stood up and walked up to her stating she was going to throw the bag of ice in Ofc. Leblanc's face. At which point hearing the commotion I returned outside to assist Ofc. Leblanc. Kate was standing up with her fist balled and her shoulders back taking a fighting stance. Officer's gave her space and attempted to find out options on getting her home. When I advised her that she was not allowed back inside Michael's residence, Kate became very angry and began screaming and yelling at officers. She was causing such a commotion that neighbors in the next building began turning on their patio lights to see the commotion. Kate then ignored what I was saying and started walking towards the front door. Kate lunged toward the front door, in an effort to get past Sgt. Vanness who was standing beside the front door and to go inside. At that time Kate was placed under arrest.</p> <p>While walking the defendant to my patrol vehicle, she was still screaming and intentionally kicked behind her striking Sgt. Vanness in the right leg.</p>
