As I pulled into the entrance of the development, I saw a [REDACTED] (wearing shorts and no shirt) and Berman (wearing a long t-shirt and no pants) by the buildings west of my location. [REDACTED] was on the phone and appeared to be trying to get away from Berman. Upon seeing me, they both started to walk towards my patrol car, but she ran ahead. I exited my patrol car, Berman was irate and yelling, "I want him the fuck out of here, I want him off my property". I instructed [REDACTED] to stay where he was and he complied. [REDACTED] yelled to me, "She attacked me, she was chasing me all over and she ripped my necklace off". Berman then started to walk away from me, yelling that she just wanted him to leave. I told her to stop and I needed to talk to her. She said she didn't want to file a report and only wanted him to leave. While I was trying to talk to her, she kept yelling to [REDACTED] "Your ex told me you fucked her today" "Fuck you, you messed this up". I repeatedly had to tell her to stop yelling at him and explain to me what happened today. Berman stated she came home from work and she was "fired up" after hearing that [REDACTED] had sex with his ex. She said they were arguing and she wanted him to talk to her, but he tried to leave so she was following him to get him to talk. [REDACTED] yelled out she ripped my necklace off. She denied ripping his necklace off and said he did it himself. She then said he pushed her. Berman then said she was following him to get him to leave. I asked Berman how long they have been together and she said on and off for a year and a half. I asked if they live together and she said not now, but they had in the past and they just signed a lease to move in together.

I then spoke to [REDACTED], who stated Berman went crazy thinking he slept with his ex, which he denied. He said she scratched him and chased him and he was just trying to leave. I asked him if he pushed her and he said he probably did, trying to get away from her. [REDACTED] told me he had part of the incident on video on his cell phone and showed me the video (he forwarded it to my email, but at the time of this writing it had not come thru yet). On the video, Berman was across the room from him, blocking the doorway. I heard [REDACTED] ask her to move and say he wanted to leave. Berman said if he left he would suffer the consequences. [REDACTED] was trying to rationalize with her and told her if she didn't let him leave he was calling the cops. She comes across room and the video bounces around and you can hear a struggle. When [REDACTED] was showing me the video, Berman became more irate and yelling over at him again. She was yelling, "I can't believe you're doing this. I want you to fucking leave. James stop, don't do this". I observed redness on the back of [REDACTED] neck, which was consistent with his necklace being ripped off. I also observed several large scratches on his back, in the left shoulder blade area. [REDACTED] stated he thinks Berman did that when she was trying to push him down the stairs. [REDACTED] said when he finally got outside; she had chased him up to Military Trail and back and forth to where the building is. He said he was yelling for help and couldn't believe no one helped him or called 911. [REDACTED] said he just wanted to get his things and leave, he didn't want anything to happen to her, but she needs mental help and he wants a restraining order. I asked him if they ever lived together and he said yes for a few months and they were supposed to be moving back in together.

I went back over to Berman and told her she was under arrest for domestic battery. At this time, she stated [REDACTED] had grabbed her by the neck and she was chasing him out of self-defense. I looked at her neck and did not see any marks. I asked how he grabbed her and she squeezed her own neck with her right hand, I told her not to squeeze her neck. She said he had grabbed and choked her several times, with one and two hand holds. I looked behind her ears, at her eyes and inside her mouth for any signs of petechial bruising, there was none visible. Berman said he beat me all over and I asked where she was hurt. She said she was hurt, scratched and bruised on her arms, stomach, back and legs. I didn't see any injuries as she was describing, besides what appeared to be a couple older small bruises on her upper arms. I then took her arms to place her in handcuffs with the assistance of Ofc. Quiros, as she started to become irate and screaming again that he "beat the shit out of her". I placed the handcuffs on her wrists, which were checked for proper spacing and double locked. Berman continued to yell and scream and cry as we escorted her to my patrol car. Among the

things Berman said was that she chased him out of self-defense because he choked her, he started the fight because he was drunk and upset it took her too long to get home from work, she grabbed his necklace when trying to hold on to him when he was choking her, he was angry and calling her a slut and whore for no reason. When she was in the back of my patrol car, she said she was pregnant with his child, but he didn't know. I asked Berman how far along she was and she said 3-4 weeks. I asked her if she had taken a test and she said she had today and it was positive. Berman said she was feeling nauseous from prenatal vitamins and her stomach/pelvic area was burning like cramps. I told her I would take her to the hospital to get checked. Berman said she had video on her phone of [REDACTED] and wanted to show me. I asked where the phone was and she said in her room. I told her she couldn't go back in the house at this time, but the other officer could have [REDACTED] show him where the phone was to retrieve it. Berman also said she wanted [REDACTED] to take care of her dogs before he left, which he agreed to do. As I started to drive her to the hospital, she started screaming that he wasn't allowed in her home. I radioed that to the other officer that information. When she heard me say on the radio to no go in the home, she started screaming again that she wanted him to take care of the dogs. I advised her at this point we will not go in the house. Berman said, "I'm sorry, I'm hormonal, I don't know what I'm doing, I'm all over the place". [REDACTED] gave Ofc. Quiros the key to Berman's home (which was placed in her property). Ofc. Quiros took a written statement from [REDACTED] and gave him a Domestic Violence packet. MPO Harris responded to the scene and photographed [REDACTED] injuries, which he later entered into JPD Evidence. MPO Harris then responded to Jupiter ER to photograph Berman and she became upset/irate again and refused to have photos taken. Berman appeared to be under the influence of an unknown type alcoholic beverage and admitted to drinking after work today, prior to going home. Berman was transported to the Jupiter ER for medical clearance due to her claims of being strangled and pain in neck, back, arms, and legs and claim of being pregnant. While at the ER, Berman told me about several pre-existing injuries she has from previous accidents (neck, back and left wrist). She told me [REDACTED] targets those areas because they hurt her all the time anyway. Berman was not pregnant and was medically cleared for jail. When ER Dr. Tanabe advised Berman she was being discharged, he said, "You're beat up, but not broken, everything looks good for you to go". At this time, Berman said, "I told you he beat me up, I want to press charges". I asked her if she wanted us to take photographs of her now and she said yes. At this time there were a couple visible scratches on the back of her neck and some redness on her wrists. There were a couple small bruises on the inside of her upper arms. Berman said she felt like there was a bruise on her hip (slightly red, but she had been lying on that side) and lower back (not visible at this time). She also said she felt her lower legs were bruised from him dragging her across the carpet and down the stairs by her legs, this was the first she said about this. All areas were photographed by MPO Harris. I explained to Berman that based upon the video, the evidence on scene and her changing her account of the incident multiple times is why I determined to her to be the primary aggressor and I stand by that decision. I further said to her that the violence could have gone both ways and they may have been mutual combatants and she could explain all that to the courts, but I believe she was the primary aggressor. Berman said she wasn't lying to me and that she didn't tell me everything at first because she was protecting him. Based upon my above described investigation, I find probable cause does exist to charge Kate M. Berman with Simple Battery Domestic, as she did actually and intentionally touch or strike [REDACTED] against the will of [REDACTED] (or) did intentionally cause bodily harm to [REDACTED]. I then transported her to PBCJ without incident. There is no further information at this time.
