<p>ON 09/20/2017 AT 2034 HOURS, I RESPONDED TO 4429 CRESTDALE ST PALM BEACH GARDENS, PALM BEACH COUNTY FL IN REFERENCE TO AN AGGRAVATED ASSAULT WITH A DEADLY WEAPON. UPON MY ARRIVAL, I OBSERVED THE DEFENDANT KATHLEEN DAVIS DRIVING A BLACK MERCEDES 2 DOOR VEHICLE BEARING FL TAG 3225HM ACTIVELY DRIVING IN CIRCLES (IN THE FRONT YARD OF THE RESIDENCE) IN AN ATTEMPT TO "HIT" THE VICTIM MICHAEL SCIARRA. I OBSERVED SCIARRA ACTIVELY RUNNING IN DIFFERENT DIRECTION IN AN ATTEMPT TO AVOID THE VEHICLE BEING DRIVEN BY DAVIS. THE VEHICLE CAME TO A STOP UPON OBSERVING MY PATROL VEHICLE, AND DAVIS WAS DETAINED DUE TO HER ACTIONS THAT I OBSERVED. IT SHOULD BE NOTED WHILE I WAS DETAINING DAVIS, SHE SPONTANEOUSLY STATED SOMETHING TO THE FACT OF I THREW EGGS AT HIS CAR AND I WANTED TO RUN HIM OVER.</p> <p>I MADE CONTACT WITH SCIARRA WHO ADVISED HE WAS IN A PAST RELATIONSHIP WITH DAVIS`S DAUGHTER. SCIARRA ADVISED HE HAD A SEXUAL AFFAIR WITH DAVIS WHILE HE WAS "DATING" HER DAUGHTER. SCIARRA ADVISED HE HAD RECENTLY TOLD DAVIS`S DAUGHTER ABOUT THE AFFAIR AND DAVIS BECAME IRATE. SCIARRA ADVISED DAVIS IS IRATE DUE TO THE AFFAIR DAMAGING THE RELATIONSHIP BETWEEN MOTHER(DAVIS) AND DAUGHTER. SCIARRA ADVISED HE WAS LOCATED IN HIS RESIDENCE AND HEARD A LOT OF "BANGING" COMING FROM OUTSIDE. SCIARRA ADVISED WHEN HE EXITED THE RESIDENCE, HE OBSERVED DAVIS THROWING MULTIPLE EGGS AT HIS RESIDENCE AND VEHICLES. SCIARRA ADVISED HE ATTEMPTED TO TELL DAVIS TO STOP THROWING THE EGGS AND WAS ACTIVELY CALLING 911. SCIARRA ADVISED AT THAT TIME, DAVIS RETURNED TO HER VEHICLE AND BEGAN DRIVING THE VEHICLE IN HIS DIRECTION.
