On the **16** day of **April**, **2018** at **22:26** (Specifically include facts constituting cause for arrest.)

On 4/16/2018 at approximately 10:11pm I, Ofc B.Tiyaloglu was on patrol in my marked vehicle at the intersection of Northlake Blvd and Roan Lane. I observed a white vehicle bearing FL tag: BYRZ91 traveling westbound in the far outside lane. I conducted an NCIC/FCIC query on the vehicle which revealed the vehicle registration was expired. I activated my emergency lights and sirens and conducted a traffic stop at the intersection of Northlake Blvd and Roan Lane Palm Beach Gardens, FL 33410. Prior to my approach of the vehicle, my body worn camera was activated.

Upon approach, I observed the registered owner/driver of the vehicle later identified as Brittany Bowen seated in the driver seat and two passengers. The two passengers were later identified as Kenneth Stetser (Rear Passenger) and Kathryn Refford (Front Passenger). I advised Bowen to exit the vehicle and asked if there were any narcotics in the vehicle that I need to know about to which Bowen replied "No". I then asked for consent to search her vehicle to be which replied "No". An investigation was conducted by myself and my certified Narcotics canine (See K9 Usage Report for further). All occupants were asked to exit the vehicle and sit on the curb by the gas station vacuum pump. An FCIC/NCIC query was conducted on all three occupants by Northcom Dispatch. Northcom Dispatch advised Refford had an active Palms warrant for failure to appear which was confirmed. Refford was placed in handcuffs which were checked for proper spacing and double locked. A search was conducted on Refford and her belongings which revealed 1.16 grams of suspected heroin, multiple syringes with residue of suspected heroin and multiple spoons with residue of suspected heroin.

Based on the recent epidemic with heroin containing fentanyl, it was advised by the State Attorney of Palm Beach County and Palm Beach Gardens Police Department to refrain from field testing "Heroin" or "Heroin Paraphernalia" for officer safety purposes.

Refford was read her Miranda rights to which she advised she understood. Refford Post
