## PROBABLE CAUSE

On 8/8/2017 at approximately 9:56PM I was traveling north on Interstate 95 in the far left travel lane approaching Northlake Boulevard. I observed a white Fiat 500 pass me in the far right travel lane at an extremely high rate of speed. I accelerated and got behind the white Fiat 500 which had a Florida tag of 815MSY. I pacclocked the vehicle for approximately a quarter of a mile at 90mph in a posted 65mph zone. I activated my emergency equipment and conducted a traffic stop on the vehicle, which pulled to the right shoulder of the roadway. I approached the passenger side of the vehicle and asked the driver for her license, registration and proof of insurance. The driver provided a Florida drivers license which I used to identify her as Kayla L. Adams (FL DL: A352512877470). She also provided the registration and proof of insurance for the vehicle which was registered in her name. As I spoke to Ms. Adams I leaned into the vehicle and noticed the strong odor of an alcoholic beverage coming from her breath as she spoke. I also noticed that the driver had a noticeable slur to her speech. Her eyes were red and glassy as well. I asked the driver where she was coming from and she stated that she was coming from West Palm Beach after attending a gathering with friends. I asked her if she had any alcoholic drinks to which she replied she had a single drink approximately 3 hours ago. I asked Ms. Adams to step outside the vehicle and spoke to her in front of my marked patrol vehicle. As I was standing directly next to her I continued to smell the strong odor of an alcoholic beverage coming from her breath. Her eyes were still red and glassy and she continued to have a noticeable slur to her speech as she spoke. I asked her to perform Standardized Field Sobriety Exercises (SFSEs) which she agreed to perform. Before administering the exercises I asked Ms. Adams if she had any medical conditions that would prevent her from performing the exercises to which she replied "no". She stated "no" when asked if she was under the care of a physician. She also stated that she did not wear contacts and her natural eye color was blue, which was observed. She did state that she wears reading glasses occasionally. She agreed that the surface upon which the exercises were performed was relatively flat and free of obstructions. The results of those exercises are outlined below.

## Horizontal Gaze Nystagmus Exercise

- Unsmooth, jerky tracking of stimulus
- Horizontal gaze nystagmus at maximum deviation in both eyes
- Horizontal gaze nystagmus prior to 45 degrees
- Noticeable orbital sway

## Walk and Turn Exercise

- Could not remain in starting position
- Did not walk heel to toe as instructed on any step, with an approximately 4 inch gap between the heel and toe during the steps
- Used arms to balance

## One Leg Stand Exercise

- Placed foot down at 18 seconds
- Used arms to balance

After completion of the exercises I determined that there was probable cause to believe that Ms. Adams was operating a motor vehicle while under the influence and was placed under arrest for DUI at approximately 10:12PM. She was handcuffed behind her back in placed in the backseat of my marked patrol vehicle. After her vehicle was towed from the scene I transported her to the Palm Beach County Breath Alcohol Testing facility. After a 20 minute observation period I asked Ms. Adams to provide a breath test sample to test for the alcoholic content of her breath. She refused to provide the breath test sample at approximately 11:26PM after she was read the Implied Consent Warning on camera. Ms. Adams was subsequently transported to the Palm Beach County Jail without incident. All events occurred in Palm Beach County, FL.

Note: My patrol vehicle is not equipped with in car video.
