


Cpl. Yerlan and I observed a W/F, identified through PALMS, as Kayla Amargos (DOB 10/21/1983) at 602 S Dixie Highway (Chevron Gas Station) Lake Worth, FL 33460. Amargos was sitting outside of the Chevron Gas Station, crouched down behind bushes, loitering on the curb and was not conducting any business related activities inside. We then approached her and observed that she was putting on make up. Amargos was holding on to two black bags in her possession. We informed her that she cannot trespass on the property as administered through Sheriff's Office posted signs on the business. She advised that she was not aware of the signs. She stated that she was not a customer at the business and did not intend to conduct business.

We then gathered her information and she spontaneously uttered that she had a "rig" on her. She then pulled out a syringe from within her bra and placed it on the floor and stated she used the syringe for narcotic use. Post Miranda, Amargos informed us that she used the syringe approximately four hours ago, by injecting heroin intravenously. A search was then conducted of her two black bags and we were able to find (4) more syringes with residue and a glass crack pipe with residue. We then placed Amargos under arrest and applied handcuffs to her wrists, which were checked for proper fit and double locked for safety.

Based on physical evidence and post Miranda statements, I found Kayla to be in violation of FSS 893.147(1), because she did use or possess with intent to use (5) hypodermic needles with residue and (1) glass crack pipe with residue, drug paraphernalia, for injecting, ingesting, inhaling, or otherwise introducing into the human body a controlled substance.
