On the <u>16TH</u> day of <u>JULY</u> 20<u>19</u> at <u>14:40</u> ☐ A.M ☒ P.M (Specifically include facts constituting cause for arrest.) On the above date and time, Kayleigh Peterson did knowingly commit the offense of petit Theft based upon the following: Peterson entered the JC Penny's located at 10308 W. Forest Hill Blvd in the Village of Wellington, FL. Once inside the business, Peterson selected three pairs of "AZ Easy rib tanks", 1 pair of "AZ rib baby tees", and 1 pair of Vans Dohenys, worth approximately \$148.73. Unbeknownst to Peterson, she was being observed via CCTV by Loss prevention officer Daniell Garcia. Due to Garcia's training and experience, he left the Peterson had, was in the process of, or was about to commit a retail theft. Garcia then watched as Peterson concealed all of the aforementioned items in her purse, and then attempted to walk past all points of purchase making no attempt to pay. Garcia confronted Peterson before she made it out of the store, at which time she relinquished the stolen items and admitted to the theft. Peterson was detained, at which point Garcia brought her back to the loss prevention office where he notified PBSDO of the theft. Upon my arrival, I informed Peterson that she was under arrest for retail theft. Garcia then provided me with a receipt showing the value of the items that Peterson attempted to take, a sworn witness statement, and a CD-R disc showing the crime in progress. Once I received these items, I relocated Peterson to the mall security office to complete arrest paperwork. Once inside the mall office, Peterson was formally trespassed from the Mall at Wellington Green and its surrounding properties by PSC Officer Burkes. It was made clear to Peterson that if she returned to the property on or before 07/17/2020, she risked being arrested for trespass after warning. I believe the aforementioned facts form the probable cause necessary to charge Kayleigh Peterson with petit theft pursuant to F.S.S. 812.014 (2e).
