


P R O B A B L E	On 05/27/2018 at approximately 1704 hours, I responded to 154 Sandbar Dr. in the Town of Jupiter, Palm Beach County, FL as a backup unit for Officer K. Pope who responded to a call of an unwanted guest at 1352 S US Highway 1 (Cabo Flats). At the time I was driving a fully marked Jupiter Police Department patrol vehicle (vehicle 1413), I was wearing a JPD issued uniform clearly identifying myself as a Jupiter Police Officer, and I was wearing my department-issued Axon body camera.								
	Prior to my arrival, responding officers were advised that an older white male, later identified as Keith Knespler (w/m; 08/08/1958), was intoxicated at the business and causing a disturbance. The caller further advised the male was wearing a gray shirt and left the business, southbound on S US Highway 1.								
	Approximately 6 minutes after receiving the initial call at Cabo Flats, an additional caller advised a copper colored Ford crew cab pickup truck struck a speed limit sign near the intersection of Marcinski Rd, and S US Highway 1. The witness advised the vehicle should have front-end damage. Responding officers located the vehicle in the driveway of 154 Sandbar Dr. It should be noted that, while responding to the aforementioned residence, I observed a 35 MPH speed limit sign on the north side of Marcinski Rd. that was knocked over with, what appeared to be, fresh tire tracks in the grass leading up to the sign.								
	Upon arrival, I observed an older white male (Knespler) handcuffed on the ground outside the aforementioned residence. Knespler was handcuffed and lying in the grass, on the south side of the driveway. Knespler appeared to be struggling with officers on scene and was extremely verbally aggressive, shouting various obscenities at officers in the area.								
C A U S E	I made contact with Officer Pope and PFC Levinstein while other officers helped restrain

Knespler, who was continually struggling around on the ground and verbally berating officers. I was advised that Officer Pope located Knespler's vehicle, bronze 2011 Ford F-150 bearing FL tag # MBP125 (with the vehicle running) and located Knespler passed out behind the steering wheel. I was also advised that officers removed the keys from Knespler's vehicle prior to him waking up. When he woke up, he exited the vehicle, despite officers advising him to stay in the vehicle, using the door to steady himself. Knespler attempted to walk past Officer Pope and PFC Levinstein, who were standing between Knespler and the garage door. Officers grabbed Knespler's arms and ordered him to stop, which he refused. Knespler tensed his muscles, was escorted to the ground, handcuffed, and held for responding backup units. See supplements from Officer Pope and PFC Levinstein.

I assisted officers on scene with holding Knespler still until PBCFR Rescue 18 arrived to treat him. The entire time I was holding Knespler, he was extremely irate (yelling obscenities at officers) and I could smell the strong odor of an unknown alcoholic beverage on his person, which intensified as he spoke. I also noted that Knespler had slurred speech while he was shouting at officers. Knespler continued to struggle with officers while on the ground, despite being handcuffed. Intermittently, Knespler would quiet down and stop resisting for several seconds before starting back up again.

Upon the arrival of PBCFR. Knespler was uncooperative with Fire Rescue personnel and was administered 400mcg of Ketamine. Officers and Fire Rescue waited for the drug to take effect and ultimately transported Knespler from the scene (PBCFR Run # 18-057400) to Jupiter Medical Center. I followed immediately behind the ambulance.

Prior to leaving the residence, I observed noticeable damage to the front of Knespler's truck. The damage was on the front driver side of the vehicle, and was consistent with damage incurred from striking a sign, as stated by the witness.

Upon arrival at JMC, I was advised by hospital staff that Knespler was going to be held at the medical facility for an extended period of time, making obtaining a breath sample impossible and impractical. Due to the observations of the initial officers on scene (unsteady on his feet) and my observations (verbally aggressive, mood swings, odor of unknown alcoholic beverage, and slurred speech), I advised Knespler he was under arrest for DUI and requested he provide a lawful sample of his blood for the purpose of determining the alcohol content and/or the presence of chemical or controlled substances. Knespler did not respond.

I read Knespler Implied Consent from a prepared text, omitting the sentence that if he refused to submit to a lawful test of his breath, urine, or blood, he would be committing a misdemeanor. I again requested that Knespler provide a blood sample and he did not reply.

Pursuant to FSS 316.1932(1)(C) stating "Any person who is incapable of refusal by reason of unconsciousness or other mental or physical condition is deemed not to have withdrawn his or her consent to such test." Due to the fact that Knespler was not conscious, I determined that he had not withdrawn his consent to a blood test.


Knespler's blood was drawn by Mila Reitz (JMC Phlebotomist) at 1851 hours. Both blood vials were immediately sealed and placed in the provided blood sample box, which was immediately secured on both sides with blue evidence tape. The blood was later submitted to JPD evidence and a PBSO Laboratory Request form was completed to perform a toxicological analysis of the specimen. I also completed a letter to JMC requesting his medical blood specimen be preserved.

I waited for Knespler to be medically cleared and transported him to the PBC Jail where he was booked for the following charges:

I believe Probable Cause exists to charge Keith Knespler with DUI because he was in actual physical control of a vehicle, while under the influence of alcoholic beverages or chemical substances as set forth in Florida Statute 877.111, or a controlled substance as set forth in Chapter 893 or any combination thereof, and was affected to the extent that his normal faculties were impaired, contrary to Florida Statute 316.193(1).

I believe Probable Cause exists to charge Keith Knespler with Resisting Arrest because he did resist, Officer Pope and PFC Levinstein, law enforcement officers of the Jupiter Police Department, in the execution of a legal process or in the lawful execution of a legal duty, without offering or doing violence to the person of such officer, contrary to Florida Statute 843.02.

I believe Probable Cause exists to charge Keith Knespler with Leaving the Scene of a Crash involving property damage because he did drive a vehicle involved in a crash resulting only in damage to a other property and did fail to immediately stop such vehicle at the scene of such crash or as close thereto as possible and forthwith return to the scene and remain at the scene of the crash until he or she fulfilled the requirements of Florida Statute 316.062.
