Gray Volvo XC90 (Florida tag CVEK40) was northbound on N. Military Trail in the left lane, traveling at a visually estimated 60 miles per hour in a posted 45 MPH zone, nearing Elm Ave. Upon stopping at the solid red indicator at the aforementioned intersection, the vehicle accelerated through the intersection, disregarding the still-solid red light. I effected a traffic stop on the vehicle and made contact with the sole occupant and driver, identified as Keith Douglas Zlomsowitch, by his Florida driver license.

OBSERVATION OF DRIVER:

Zlomsowitch appeared confused as to why he was being stopped, and had glassy eyes.

Zlomsowitch stated that he had was on his way to his home after leaving from Dorian's, a bar establishment in West Palm Beach, Florida, where he consumed "two to three" drinks.

Zlomsowitch stated that he understood the instructions and began this task with his left foot forward and counting it as his first step, contrary to the instructed right foot in front to begin. Zlomsowitch stepped off the painted solid white fog line for steps 4 and 5, did not heel-to-toe, took ten steps total, and did not turn as instructed on the initial walk. On the return walk, Zlomsowitch did not heel-to-toe ~~steps 3, 5, 6, and 7~~ and proceeded to take ten steps contrary to the instructed nine.

ONE LEG STAND:

Zlomsowitch stated that he understood the instructions and began this task with his right foot up. Used arms for balance, dropped foot at his seventh count. Zlomsowitch reattempted this task by picking up his left foot less than 6" off the ground, extended his arms outward to assist with balance, and dropped foot at counts 5, 7, and 8.

FINGER TO NOSE:

Zlomsowitch performed this task by placing his fingertip just under his nose, contrary to the instructions to place it on the tip of his nose.

ROMBERG/ALPHABET:

Zlomsowitch stated that he understood this task. He attended Arizona State, and knew his alphabet from A to Z. Zlomsowitch performed this task until the letter V, after which he followed it up and concluded the task with letter C.

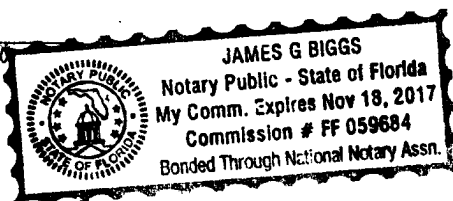
