 committed the below acts in my presence. was observed by _____ who told _____ that he/she saw the arrested person commit the below acts.
 confessed to _____ admitting to the below facts. was found to have committed the below acts, resulting from my (described) investigation.
 On the **21** day of **November** 20**17** at **2246** A.M. P.M. (Specifically include facts constituting cause for arrest.)

On 11/21/2017 at approximately 2214 hours I responded to 195 Martin Circle in reference to a domestic battery that just occurred. Upon arrival I met with Richard Briant who was standing outside of 195 Martin Circle and stated his son Keith Briant pushed him.

Richard told me that Keith was acting crazy and throwing things in the house. Stated he was afraid of his son and while he was trying to lock himself in his room Keith pushed him. Richard also told me when he got in to his room he could hear Keith yelling incoherent noises and talking to himself. I did not observe any injuries on Richard. Richard provided a sworn written statement. Photographs were taken of inside of the house and of Richard.

Keith was asked to step outside and while speaking to him in the front yard he was unsteady on his feet and I could smell the odor of an unknown alcoholic beverage coming from him. Keith stated nothing happened tonight. While I returned to speak with Richard Keith became verbally aggressive and was placed him in handcuffs by D/S R. Oragene 7759 and he began pulling away. Once in place D/S Oragene checked the handcuffs for proper fit and double locked them. Keith was advised he was under arrest for domestic battery and escorted to the rear of D/S Landa's 20328 marked patrol vehicle. While attempted to put Keith in the rear of the patrol vehicle he became combative attempting to pull away and refusing to get inside the vehicle. I went to the opposite side of the vehicle in an attempt to pull him in and he began kicking D/S Oragene with both of his feet striking D/S Oragene who was in his PBSO issued Road Patrol uniform. D/S was struck one time in the front right leg by Keith's foot. At this point I attempted a Vascular Neck Restraint to gain control of Keith. I was able to pull Keith in to the vehicle and it was secured.

Based on my investigation and the events that occurred in my presence I believe

Keith Hamilton Briant did actually and intentionally strike me, D/S R. Oragene 7759 against his will, I believe while, D/S R. Oragene 7759, was engaged in the lawful performance of a duty and while Keith Hamilton Briant knew that I was a law enforcement officer, contrary to Florida Statute 784.03(1) and 784.07(2)(b). (3 DEG FEL) (LEVEL 4)

Keith Hamilton Briant did knowingly and willfully resist, obstruct, or oppose me, D/S R. Smith 15526, a law enforcement officer of the Palm Beach County Sheriff's Office, doing violence to the person of such officer, contrary to Florida Statute 843.01. (3 DEG FEL) (LEVEL 5).

Keith Hamilton Briant did resist, obstruct or oppose me, D/S R. Oragene 7759, a law enforcement officer of the Palm Beach County Sheriff's Office, in the execution of a legal process or in the lawful execution of a legal duty, without offering or doing violence to the person of such officer, contrary to Florida Statute 843.02. (1 DEG MISD)

Keith Hamilton Briant did actually and intentionally push Richard Briant against the will of Richard Briant Richard Briant was a family or household member of Keith Briant, contrary to Florida Statute 784.03(1) and 741.283 (1 DEG MISD)

I believe probable cause exists for the arrest of Keith Hamilton Briant. Keith Hamilton was transported to West Detention Center by D/S Landa and turned over to their staff.
